On the occasion of the celebration of the centenary of the Laboratory of Archaeology of the University of Valencia, the Department of Prehistory, Archaeology and Ancient History, and the Unit of Scientific Culture and Innovation announce the contest "100 years of archaeology".

#### **RULES**

#### 1. AIM AND RECIPIENTS

- 1.1 The aim of the competition is to stimulate and enhance knowledge about archaeology in primary and secondary students, and to promote respect for the historical and cultural heritage of Valencia. Places of archaeological cultural interest will be provided in Annex II of these rules.
- 1.2 In order to participate, it will be necessary to present an unpublished work on archeology that will consist of a drawing or a photograph, according to the following two modalities:

A – Primary school students:

A1 – Up to third grade: a drawing A2 – Up to sixth grade: a drawing

B – Secondary school students: a photograph

The drawings and photographs must not have been previously awarded and the people participating in the contest are responsible for the non-existence of third party rights in the works submitted. In the case of photographs, if recognisable persons appear, a letter signed by them authorising the use of their image must be submitted.

- 1.3 The works must be sent in .jpg format to the electronic address <a href="mailto:cdeiencia@uv.es">cdciencia@uv.es</a> indicating in the subject «Competition 100 years of archaeology».
- 1.4 The document contained in Annex I of these rules must be completed together with the work.

# 2. **DEADLINE FOR SUBMISSION**

- 2.1 The deadline for submitting the Works ends on May 31, 2022.

#### 3. MONETARY AWARDS

3.1 A single prize will be awarded, which will be indivisible, for each of the modalities, and will consist of a tablet (valued at approximately €60) and merchandising material produced on the occasion of the celebration of the centenary of the Archaeology Laboratory of the University of Valencia. In addition, a guided visit to the Archaeology Laboratory of the University of Valencia and/or different archaeological sites will be organised for the centres to which the winners belong.

### 4. JURY AND VALUATION CRITERIA

- 4.1 The jury is formed by:
  - Teresa Orozo Köhler, director of the Department of Prehistory, Archaeology and Ancient History
  - Gianni Gallello, researcher at the Department of Prehistory, Archaeology and Ancient History and director of the ArchaeChemis research unit
  - Josep Montesinos Martínez, dean of the Faculty of Geography and History
  - María Jesús de Pedro Michó, director of the Prehistory Museum of Valencia
- 4.2 If a member of the jury finds any reason for abstention, they must decline to be part of it, without prejudice to the liabilities for failing to do so.
- 4. 3 For an objective assessment of works, the jury will consider the following criteria:
  - Cultural impact and contextualisation in the Valencian archaeological heritage: up to 4 points
  - Creativity and originality: up to 3 points
  - Production quality: up to 3 points
- The resolution of the award will be published on the websites of the Department of Prehistory, Archeology and Ancient History and the Scientific Culture and Innovation Unit.

## 5. AWARDING

The prizes will be awarded at a conference to be held in the first fortnight of June at the Faculty of Geography and History of the University of Valencia.

## 6. RIGHTS AND OBLIGATIONS

6.1 The submission of works implies full acceptance of these rules and of the rights and obligations arising from them. All matters not covered by these rules will be solved following the free criteria of the jury.
