

## **Resolution of the Vice-Chancellor of Sustainability, Cooperation and Healthy Life of the University of Valencia, on the provisional award of the Plan Refugio International 2024 scholarships for students.**

By resolution of the Vice-Chancellor of Sustainability, Cooperation and Healthy Life of the University of Valencia of May 25, 2024, the International Refugee Plan 2024 was convened for students and students with 9 scholarships to pursue higher studies at the University of Valencia.

Revised the applications submitted and the attached documentation, in application of the bases of the call, particularly the tenth base relating to the valuation and grading criteria,

The Vice-Rector for Sustainability, Cooperation and Healthy Life of the University of Valencia, in use of the powers conferred by the Resolution of May 20, 2022 (DOGV no. 9350 of May 30, 2022), of the Chancellor of the University of Valencia, by which certain powers are delegated to the vice-chancellors, the General Secretariat, the Management and other bodies of this university; and in accordance with the Statutes of the University of Valencia, approved by Decree 128/2004, of July 30, of the Generalitat Valenciana,

### **RESOLVE**

#### **First**

Provisionally award the Plan Refugio International 2024 scholarships to the people listed in Annex I.

#### **Second**

Establish the ranked waiting list, with the people listed in Annex II.

#### **Third**

Establish the list of excluded persons, with the persons listed in Annex III.

#### **Fourth**

In accordance with article 123 of Law 39/2015, against this resolution, which exhausts the administrative avenue, a potential appeal for reinstatement may be filed, within one month from the day following its publication, before the same body that dictates the resolution, or directly administrative contentious appeal before the bodies of the administrative contentious jurisdiction of the Valencian Community within two months, counted from the following day of its publication.
