UNFULFILLMENT OF ENROLLMENT RULES



- Credits **cannot** be divided (9 or 7,5=annual)
- First semester students only first semester subjects
- **Minimum** 18 (1 semester) or 36 (annual)
- **At least 50%** of subjects from our Degrees (**check languages**)
- **No** research papers or internships
- **No** master degree subjects
- **At least** one subject taught in Spanish
- **At least** one subject belonging to the Degree the student has been nominated for

Enrollment changes



- **Professors do not enroll**, and they cannot accept new students in closed groups:
- PLEASE do not ask professors to accept you in a closed group.
- **DEADLINE FOR CHANGES:**
 - Self-changes: September 17th and 18th –
 - Until October 15th in person at the Erasmus office!!!
- Previous acceptance of home University
- Update your Learning Agreement
- Any change in the enrollment must be accordingly changed in the LA. Enrollment and LA must be consistent: They must contain the same subjects, otherwise there will be problems with validations of grades at home University.

EXAMS and ACADEMIC INFO



- **In-person exams.** Online exams are NOT allowed.
- Every student has **two opportunities** to pass an exam (1st and 2nd call). The 2nd one can only be used when the 1st one has not been taken (NP), or the subject has been failed.
- **Only in the official dates** (already available at “Secretaría Virtual”) **note** that one same subject may have different exam dates in different Degrees)

AT THE END OF THE STAY



- Make sure that **Learning agreement** and changes are signed.
- Guidelines from the Central Service for International Relations UV:
 - 1.- **Transcript of records** once the grades have been processed at the end of your stay
 - 2.- **Certificate of attendance**
