Important enrollment rules



- ECTS cannot be divided
- Groups have a maximum number of students
- Professors do not enroll (always at Erasmus Office)
- You can select subjects from other Faculties but at least 50% must belong to the Law Faculty

After the enrollment

- Fee of 7,00 € aprox. which must be paid at the Bank Office (for student card and insurance)
- Once paid, bring it to the Erasmus Office: username and password <u>xxxx@alumni.uv.es</u> (personal accounts are not allowed, hotmail, gmail...)

Enrollment changes

• Deadline:



Second semester courses: From 11 February until 1 March 2019

- Maximum twice.
- Any change in the <u>enrollment</u> must be accordingly changed in the <u>Learning Agreement (!!!!</u>)

Learning agreement and enrollment sheets are two different documents but must be consistent: they must contain the same courses.

EXAMS and ACADEMIC INFO



- Every student has two opportunities to pass an exam (first and second call). The second call can only be used when the first call has not been taken, or it has been failed.
- Only in the official dates (already available)
