

EXAMINATION REGULATIONS

1. Examinations, whether in first or second sitting, shall always be held within the official examination period established in the academic calendar.
2. Examinations in core and compulsory subjects from the same course and year cannot be held on the same day.
3. If examinations coincide within the same morning or afternoon session, the corresponding Department, established according to the criteria indicated below, will arrange an additional sitting for those students than cannot attend the official sitting. In order to apply for this additional sitting, students must justify that they are entered for the coinciding examination.
4. The Department arranging the additional sitting, shall be established as indicated below:
 - a) In the case of coinciding timetables between core subjects, the additional sitting shall be arranged by the Department giving the core subject from the higher year.
 - b) In the case of coinciding timetables between core and optional subjects, the additional sitting shall be arranged by the Department giving the optional subject.
 - c) In the case of coinciding timetables between optional and/or elective subjects, the additional sitting shall be arranged by the Department giving the subject from the higher year. In the case that both subject correspond to the same year, the additional sitting shall be arranged by the Department that has fewer students registered.
5. Applications for additional sittings due to coinciding exams within the same morning or afternoon sessions, shall be presented by students to the corresponding subject coordinator within 10 days of the publication of the final list of examination timetables.
