DOCUMENTS TO BE ATTACHED:

1. Certified copy of the document that proves the identity and nationality of the applicant (DNI, NIE or passport).

2.Certified copy of the qualification for which equivalence is being requested or the corresponding certificate of issue.

3.Certified copy of the qualifications that qualified the holder for admission to doctoral studies.

4.Copy of the academic transcript of the subjects completed by the applicant to obtain the doctoral degree. It must state the official duration of the course in academic years, the subjects studied, the number of hours devoted to each and the marks obtained.

5. Copy of the doctoral thesis, which must indicate the members of the examination panel and the mark obtained, together with a summary of 10-40 pages in any of the official languages of the university, unless the thesis is written in Valencian, Spanish or English.

6. Explanatory report of the thesis, in Spanish or Valencian, including the references and publications stemming from the doctoral thesis.

7.Authorisation for the Universitat de València to request validation from the authority issuing the documents submitted, if deemed necessary.

8. Proof of payment of the fee.

RDOCUMENTS ISSUED OUTSIDE SPAIN MUST:

1. Be official and have been issued by the relevant authority, in accordance with the law of the country in which they were issued.

2. Have been legalised by diplomatic services or, if applicable, by means of the Apostille of the Hague. This requirement does not apply to documents issued by the authorities of the Member States of the European Union or states signatory to the European Economic Area Agreement.

3. Be accompanied, if applicable, by the corresponding official translation into any of the official languages of the Valencian region.
