### 1. CV: Short Overview

J. Esparcia is a full Professor of Geography (January 2006), with a PhD in Geography from the University of Valencia (1990) and a PhD in Sociology from the Autonomous University of Barcelona (2017). He currently holds six sexennial periods of positive evaluated research.

He has been the director of the inter-university doctoral programme in [Local Development and International Cooperation](#) (2020-2023), in which the Universities of Valencia, the Polytechnic University of Valencia and the Jaume I University of Castelló participate.

He also leads the journal AGER ([Journal of Studies on Depopulation and Rural Development](#)), of whose editorial board he became deputy director in 2015, and has been its director from 2019 to the present.

He is director and principal investigator of the Research Group Unit for Rural Development and Public Policy Evaluation (UDERVAL), in which he has supervised a total of 13 doctoral theses, with several more in progress.

He currently participates as evaluator in different committees and for different agencies, both national (ANEP, Agència per a la Qualitat del Sistema Universitari de Catalunya, Agencia Andaluza del Conocimiento, Agencia para la Calidad del Sistema Universitario de Castilla y León, Axencia para a Calidade do Sistema Universitario de Galicia, etc.), and international (for example, the Czech Science Foundation -2018/2023-, the Horizon 2020 Programme of the European Commission, and he is a member of the college of evaluators of the European Science Foundation).

During the years 2019 and 2020 he has been the director of the University Chair of the Depopulation Agenda of the region of Valencia, at the University of Valencia. On this subject, he was the director of the international seminar "Policies against depopulation

under debate: what and how?" (October 2020), and the one on "Five years of Public Policies against Depopulation. Assessment and perspectives" (October 2023). He has also published short articles, such as "Depopulation: demographic challenge and national challenge", "Immigration: local solutions to rural depopulation", and "Rural depopulation: a territorial problem with historical roots". He has published papers dealing with different aspects on rural processes and policies on rural development, including depopulation and rural proofing.

From 2004 to 2009 he was Manager of Social Sciences in the National R&D&I Programme (Directorate General for Research). He was also the Spanish representative on the Management Committee of the European Science Foundation (2005-2007), and was appointed by the Ministry of Science and Innovation and the Spanish National Research Council (CSIC) as the Spanish representative on the Social Sciences Standing Committee of the European Science Foundation (2007 to 2009).

During 2014 and 2015 he participated in the International Commission of Experts that assessed the Portuguese system of R&D centres, in the area of Social Sciences, commissioned by the Fundação para a Ciência e a Tecnologia (Foundation for Science and Technology).

He has also collaborated in the evaluation of research projects and the ACADEMIA programme of the National Agency for Evaluation and Prospective ([ANECA](#)), and has been a member of different project evaluation commissions in the Directorate General for Research (Ministry of Science and Innovation, later Ministry of Economy and Competitiveness), as well as in the COFUND and Marie Curie Actions programmes of the European Commission.

He has been a member of the National Commission for the Evaluation of Research Activity ([CNEAI](#)), as a member (2013), secretary (2014) and president (2015) of Area 10, and between 2016 and 2021 he chaired the Commission for the Accreditation of University Teaching Staff (E-19) at the National Agency for Quality Assessment and Accreditation ([ANECA](#)). In 2016 he has been area coordinator at the Spanish Foundation for Science and Technology ([FECYT](#)) for the evaluation of scientific journals, reviewer for several years, and from 2022 he is a member of the Academic Publishing Quality Evaluation Commission.

He was Head of the Department of Geography at the University of Valencia (April 2009 to October 2010), and director of the Master in Management and Promotion of Local Development at the Univ. of Valencia until September 2011. He followed a second PhD (PhD Programme in Sociology, Autonomous University of Barcelona), with the PhD thesis on "Social Capital and Territorial Development: Social Networks and Leadership in the new Rural Dynamics in Spain".

In 1998 he launched the first postgraduate course for local development agents, which has evolved into the official Master's degree in Management and Promotion of Local Development (Inter-University Institute for Local Development), of which he was the director until September 2011. He has taught doctorate and master's degree courses at the University of Valencia and different Spanish universities, as well as numerous conferences, mainly on the subjects of local development in rural areas and methodologies for evaluating public policies (mainly rural development).

In 1993 he founded UDERVAL (Research Unit for Rural Development and Public Policy Evaluation), which was integrated into the Inter-University Institute for Local Development of the Valencian Community in 2003. This Unit is currently one of the Research Groups recognised in the research structures of the University of Valencia, of which he is the director. About 20 PhD theses on different topics related to rural dynamics, including issues of social capital and social innovation, have been carried out in the Unit.

He has carried out different specialisation stays in Canada and Great Britain as a visiting scholar (University of Toronto, 1994-95; York University, 1996; and Cheltenham College for Higher Education, 1998).

In his professional scientific activity, he collaborated with the Spanish Unit of the European LEADER Observatory, later the Cell of Animation and Promotion of Rural Development (Ministry of Agriculture), and was a member of the Editorial Board of the journal *Current LEADER-Rural Development* (1999-2004), in which he published numerous articles.

He has carried out and participated in the evaluation of rural development policies, mainly LEADER and PRODER programmes, both for the regional government of Valencia, central government in Spain and the European Commission. In 2011 he was part of the group of experts who have evaluated both programmes for the Directorate General of Rural Development, belonging to the current Ministry of Agriculture, Food and Environment (2012). He was appointed member of the Advisory Body of the regional government of Valencia on rural development (local action groups, development strategies and their monitoring, etc.), for the period 2016-2020. He has coordinated the expert's group in charge of the evaluation of LEADER groups and Local Development Strategies in the region of Valencia (for the period 2023-2027).

He is a member of the Scientific Committee of several national journals, and actively participates in the evaluation of articles in journals such as *Sociologia Ruralis*, *Journal of Rural Studies*, *International Journal of Sustainable Development*, *Urban Geography*, *International Journal of Sociology of Agriculture and Food*, *The Geographical Journal*, *Geoforum*, *African Journal of Agricultural Research*, *Ecological Indicators*, *International Journal of Sustainable Development*, as well as national journals such as *Investigaciones Regionales*, *Revista Internacional de Sociología*, *Papeles de Geografía*, *Revista Española de Estudios Agrosociales*, *Revista de Estudios Regionales*, *Estudios Territoriales*, *Geographicalia*, *Anales de Geografía de la Universidad Complutense*, *AGER-Revista de Estudios sobre Despoblación y Desarrollo Rural*, *Cuadernos de Geografía*, etc.

He has conducted research through on different competitive research projects, mainly funded by the European Commission and, to a lesser extent, the Ministry of Science and Innovation or other public administrations. In addition, he has worked on projects and contracts, also mainly for public administrations.

His scientific activity has focused on a basic line of research, local and rural development, especially the processes of socio-economic transformation in rural areas, the role of new activities, analysis of the relationships between social capital and territorial development (for example, through the EU Horizon Research Project ROBUST), and specifically the role of social networks, leadership, elites and power structures in the socio-economic

dynamics of rural areas. He is paying special attention to the socio-territorial dynamics associated with depopulation processes in rural areas. Currently he is involved in research on depopulation issues through several research projects. For example, he is coordinator of a project of a national level (2021-2025), with the participation of six other universities and specialists from various fields, including sociology, economics, social psychology, urban planning, geography and administrative law.
