## INSTRUCTIONS TO REQUEST THE REGISTRATION OR MODIFICATION OF DATA OF NATURAL OR LEGAL PERSONS IN THE UNIVERSITAT DE VALÈNCIA'S THIRD PARTY DATABASE

### 1. Natural persons with electronic signature

Applicants will send to the Management Unit or their contact person at the UV, via email, **the third parties application form** electronically signed

### 2. Legal persons with electronic signature

Applicants will send to the Management Unit or their contact person at the UV, via email, **the third parties application form** signed with [an electronic certificate of the company's representative](#).

### 3. Processing without electronic signature

When applicants don't have an electronic signature (in case of being a natural person) or an electronic representative certificate (in case of being a legal person), or it cannot be validated on the VALIDE platform, must send to UV management units the following documentation as PDF:

- a. **Third parties application form** with a handwritten signature.
- b. **NIE / PASSPORT or identity card** of the country of who is signing.
- c. **Ownership bank certificate** of the current account declared
- d. If as representative of a company, the **certificate of the Companies Registry** relative upon the appointment of the signatory and validity of his position as administrator or legal representative, or **the power of attorney** of voluntary representation.
