DOUBLE DEGREE PROGRAMME IN THE BACHELOR'S DEGREE IN INTERNATIONAL BUSINESS -
INTERCULTURAL STUDIES AND THE BACHELOR'S DEGREE IN INTERNATIONAL BUSINESS**

BY AND BETWEEN

Parties:

Of the one part, Heilbronn University of Applied Sciences, hereinafter also referred to as Heilbronn University, having its legal address at 74091 Heilbronn, Max-Planck-Str. 39, Germany with fiscal identification number VAT 811275936 and represented herein by its Vice-Rector for Internationalization and Diversity, Prof. Dr. Ruth Fleuchaus, acting by virtue of Landeshochschulgesetz Baden-Württemberg (LHG BW)

and

Of the one part, the Universitat de València Estudi General (hereinafter referred to as UV), with legal address at Avinguda de Blasco Ibáñez, 13, 46010 Valencia, with fiscal identification number Q-4618001-D and represented herein by its rector, Ms María Vicenta Mestre Escrivá, acting by virtue of Article 94 of the Statutes of the Universitat de València, which were approved by Decree 128/2004, of 30 July, of the Consell de la Generalitat (DOGV 2004/8213), amended by Decree 45/2013, of 28 March, of the Consell (DOGV 2013/6994) and entitled to enter into this agreement by virtue of her appointment by Decree 25/2022, of 11 March, of the Consell (DOGV 2022/9297).

The parties to this agreement hereby

DECLARE

- I. That on 25 March 2021, the parties signed a collaboration agreement for Dual Degree Programme (in the Bachelor's Degree in International Business - Intercultural Studies and the Bachelor's Degree in International Business) which came into force on 25 March 2021.
- II. The clause 13 of the aforementioned agreement provides that the parties may decide to extend the agreement by express consent.



The parties, acting in their aforementioned capacities, acknowledge the other's legal capacity to extend this agreement according to the following

CLAUSES

ONE.- EXTENSION OF THE AGREEMENT

The aim of this agreement is to approve an extension for the agreement signed by the parties on 25 March 2021 for the double degree programme in Bachelor's Degree in International Business from UV and the Bachelor's Degree in International Business - Intercultural Studies from Heilbronn University of Applied Sciences, which came into force on 25 March 2021.

The validity of the mentioned agreement is extended for four more years, from the date of its expiration and up to 25th March 2029.

TWO.- TERMS OF THE EXTENSION

This extension is signed maintaining the terms and conditions established in the agreement signed in 2021.

This agreement, if handwritten signed, will have 4 copies, 2 (two) of which will be in English and 2 (two) in Spanish, all valid and in accordance with the law. In case of incompatibility of interpretation, the English text shall prevail over the texts in the other languages.
