



**EXTENSION OF THE AGREEMENT BETWEEN THE UNIVERSITAT DE VALÈNCIA AND THE
HOCHSCHULE BREMEN FOR THE DOUBLE DEGREE PROGRAMME
IN THE BACHELOR'S DEGREE IN INTERNATIONAL BUSINESS FROM THE UNIVERSITAT DE
VALÈNCIA AND THE BACHELOR'S DEGREE IN BETRIEBSWIRTSCHAFT/ INTERNATIONALES
MANAGEMENT FROM THE HOCHSCHULE BREMEN**

BY AND BETWEEN

Parties:

Of the one part, the Hochschule Bremen, hereinafter referred to as "HS-Bremen", located at Werderstrasse 73, 28199 Bremen and represented by Professor Dr. Konrad Wolf, Rector of Hochschule Bremen, with full powers in regard to this Agreement

and

Of the one part, the Universitat de València Estudi General (hereinafter referred to as UV), with legal address at Avinguda de Blasco Ibáñez, 13, 46010 Valencia, with fiscal identification number Q-4618001-D and represented herein by its rector, Ms María Vicenta Mestre Escrivá, acting by virtue of Article 94 of the Statutes of the Universitat de València, which were approved by Decree 128/2004, of 30 July, of the Consell de la Generalitat (DOGV 2004/8213), amended by Decree 45/2013, of 28 March, of the Consell (DOGV 2013/6994) and entitled to enter into this agreement by virtue of her appointment by Decree 25/2022, of 11 March, of the Consell (DOGV 2022/9297).

The parties to this agreement hereby

DECLARE

- I. That on 7th October 2021, the parties signed a collaboration agreement for Dual Degree Programme (in the Bachelor's Degree in Betriebswirtschaft/ Internationales Management (BIM) from the HS-Bremen and the Bachelor's Degree in International Business from the UV).
- II. The clause 13 of the aforementioned agreement provides that the parties may decide to extend the agreement by express consent.

The parties, acting in their aforementioned capacities, acknowledge the other's legal capacity to extend this agreement according to the following



CLAUSES

ONE.- EXTENSION OF THE AGREEMENT

The aim of this agreement is to approve an extension for the agreement signed by the parties on 7th October 2021 for the double degree programme in Bachelor’s Degree in International Business from UV and the Bachelor’s Degree in Betriebswirtschaft/ Internationales Management (BIM) from the HS-Bremen, which came into force on this date.

The validity of the mentioned agreement is extended for four more years, up to 7th October 2029.

TWO.- TERMS OF THE EXTENSION

This extension is signed maintaining the terms and conditions established in the agreement signed in 2021.

The parties hereto sign two equally valid counterparts of this agreement in English.
