



# AGREEMENT FOR THE DOUBLE DEGREE PROGRAMME IN INTERNATIONAL BUSINESS FROM THE UNIVERSITAT DE VALÈNCIA, SPAIN AND INTERNATIONAL BACHELOR OF BUSINESS ADMINISTRATION, GROUPE KEDGE BUSINESS SCHOOL, MARSEILLE, FRANCE

#### PREAMBLE:

Universitat de Valencia (UV) represented by Dª María Vicenta Mestre Escrivá, Rectora Magnífica of the Universitat de València, with registered office in Avda. Blasco Ibáñez, nº13, 46010 Valencia, Spain, and with VAT number: Q-4618001-D, acting on behalf of and representing it, legitimized for this act by virtue of article 94 of the Statutes of the University of Valencia, approved by Decree 128 / 2004, of July 30, of the Consell (DOGV 2004/8213), modified by Decree 45/2013, of March 28, of the Consell (DOGV 2013/6994) and empowered as of its appointment by Decree 25/2022, of March 11, of the Consell (DOGV 2022/9297).

and

**Groupe KEDGE Business School**, hereinafter referred to as "KEDGE BS", operating under Association Act of 1901 n° SIRET 514 005 123 00062, Code APE 8542Z, located at Domaine de Raba, 680 Cours de la Libération, 33405 TALENCE Cedex, France, and represented by Dr Santiago Garcia-Rodriguez, Vice President for Development and International Relations, acting on behalf of Jean-Daniel BEURNIER, President of the Board of Directors, duly authorised to enter into this Agreement;

Agree to continue their academic cooperation through dual degree exchange at the bachelor level as follows:

#### 1. PURPOSE

Universitat de Valencia and KEDGE BS signed an agreement in 15 April 2019 for the double degree programme in the Bachelor's Degree in International Business from the Universitat de València and Bachelor of Business Administration (IBBA) programme from Groupe Kedge Business School. This agreement was addended in 15 January 2021 as a consequence of changes in study programme of IBBA based in Marseille Campus of Kedge BS.

The parties, acting in their aforementioned capacities, acknowledge the other's legal capacity to enter into this agreement according to the concerted actions which are detailed in the present Appendix. This document sets the academic terms for the establishing of a dual degree programme at the bachelor level.





#### 2. PROGRAMMES AND DEGREES

- 2.1 The dual degree programme involves students from the following programmes:
  - (a) At KEDGE BS:
    - the International Bachelor of Business Administration (IBBA) programme based in Marseille.
    - EBP International (five-year embedded Degree) at the Bachelor level based in Bordeaux campus.
  - (b) At Universitat de Valencia: the BA in International business in UV.
- 2.2 Upon successful completion of the course of studies the degree-seeking students will receive the following degrees:
  - (a) Students from Universitat de Valencia: The (IBBA) International Bachelor of Business Administration diploma from KEDGE BS.
  - (b) Students from KEDGE BS: the BA in International business in UV
- 2.3 Both degrees are state-recognized in the home country.

#### 3. NUMBER OF STUDENTS

- 3.1 Each year during the life of this Agreement, the institutions may generally send to the other institution twenty (20) of new students in the dual degree programme. At KEDGE BS ten (10) of these will be coming from the IBBA program and ten (10) from the EBP program. If all of the dual degree places are not filled, the vacant places may be filled by non-degree seeking students on simple exchange. This Agreement is based on the reciprocity principle; however, the number of students exchanged does not have to be exactly reciprocal each year but should balance over the life of this Dual Degree Agreement.
- 3.2 Both institutions will review the exchange programme annually for any imbalances in the number of exchange students and may adjust the number of students over the duration of this Agreement so as to rectify any imbalance.

### 4. ACADEMIC PROGRAMME OF STUDENTS

4.1 UV students registered in the Dual degree program in UV will undertake a three semester course of study at KEDGE BS, Marseille campus (courses in French and English)

KEDGE BS students registered in the EBP International programme or IBBA programme will undertake a three semester course of study at UV (courses in Spanish and English).

- 4.2 The course of study for:
  - KEDGE BS students from either the IBBA or the EBP program shall consist of eight (8) semesters:
    - Semester one, two and three (1, 2 and 3) will be at KEDGE BS.
    - Semester five, six and seven (5, 6 and 7) will be at UV.

- Semester four and eight (4 and 8) will be in work placement. The placement in semester eight (8) is recommended to be in Spain (but company can offer missions abroad) and includes the Bachelor thesis and the Bachelor project.
- UV students shall consist of eight (8) semesters:
  - o Semester one, two, three and four (1, 2, 3, 4) will be at UV
  - Semester five, six and seven (5, 6 and 7) will be at KEDGE BS.
  - Semester eight (8) will be in work placement preferably outside Spain. The semester 7 and 8 include the Bachelor Thesis.
- 4.3 The programme of study at KEDGE BS will consist of regularly offered courses taught in English. A majority of these courses will be taught by regular KEDGE BS faculty.
- 4.4 The programme of study at UV will consist of regularly offered courses taught in Spanish and English.
- 4.5 The programme of study for students seeking the dual degree is as follows:

Adjustments in the programme of study may be implemented at a later date by mutual consent of the institutions.

4.6 To the degree reasonably possible, each institution will make internship opportunities available to students as part of their exchange programme requirements. The internships will be in the students' area of concentration.





4.7 A detailed outline of the programme of study followed by the names of the dual degree seeking students will be established and communicated in writing by Programme Directors of each institution six (6) months prior to the effective date the student exchanges take place. Additionally, each institution shall include a description of the programme of study, including degree requirements, in printed materials available to the students.

#### 5. DEGREE REQUIREMENTS

5.1 In order to obtain the International Business Degree in UV the students must complete:

A total number of 240 ECTS, including

- 90 ECTS awarded from UV through regular coursework
- 30 ECTS for the internship recommended to be in Spain, including Bachelor Thesis and Bachelor Project
- 5.2 In order to obtain the IBBA diploma from KEDGE BS, the students must complete:

A total number of 240 ECTS, including

- 90 ECTS awarded from KEDGE BS through regular coursework including Bachelor Thesis
- 30 ECTS for the internship outside Spain
- a Be-U report (supervised by the Career center)
- one Pro-act (concrete project)
- Proof of a minimum B2 level in English language (through an official test such as the TOEFL minimum 79 or TOEIC minimum 785 or IELTS minimum 6.5 or Cambridge First) if not submitted during the admission
- Proof of progress in French language (ie: from beginner level to elementary level achieved at the end of the studies)

## 6. SELECTION OF STUDENTS

- 6.1 UV students must apply to KEDGE BS for participation in the programme by May 15. KEDGE BS students must apply to UV for participation in the programme by May 31.
- 6.2 Each institution will forward to the partner institution only its most qualified applicants each year. Each institution will have the final authority to determine which students from the partner institution will be allowed to undertake a course of study, provided that neither institution shall determine qualified applicants on the basis of any non-educational criteria, including but not limited to race, creed, colour, age, gender, sexual orientation, national origin, marital status or religion.
- 6.3 Each institution will select its students for the exchange programme in accordance with its own criteria and procedures but subject to the following guidelines:
  - (a) Exchange students must meet the language requirements set by the host institution:
  - Exchange students seeking admission to KEDGE BS must show proof of English proficiency: either by submitting a minimum of TOEFL IBT 79 or IELTS 6.0, B2 in English (or equivalent),





or a certificate of English proficiency from a language instructor (non-native English-speaking students only) and B1 minimum in French

 Exchange students seeking admission to UV must have a B1 minimum level of Spanish language proficiency, and a B2 Minimum in English.

#### 7. INTERNATIONAL COORDINATING OFFICE

- 7.1 Each institution agrees to appoint an overall International Coordinating Office that is responsible for defining the operational elements of the student exchange, described in separate document titled "Mobility Data Sheet." This document is updated jointly by each institution on a yearly basis.
- 7.2 The International Coordinating Office serves as the contact on campus, is responsible for arrangements associated with visits, ensures the necessary approvals are in place, receives official transcripts from the partner institution, and attends to the general welfare of the exchange students. The list of relevant contact persons will be updated each year.
  - (a) For UV, the name of the Vice Dean of International Relations is Dr Asuncion Hernandez (asuncion.hernandez@uv.es). The DD coordinator in charge is Ms. Ana Zorio (ana.zorio@uv.es).
  - (b) For KEDGE BS, the name of the International Coordinating Office is the International Student Office (ISO), which is currently headed by Mrs Anna Nerriere (

# 8. ACADEMIC SUPPORT OBLIGATIONS

#### 8.1 Each institution will:

- (a) Register the other institution's exchange students as degree-seeking students of the host institution, while maintaining their student status with their home institution.
- (b) In accordance with the programme of study, permit the other institution's exchange students to enrol at the host institution in courses for which they are qualified, as long as places are available.
- (c) Provide advice and information to exchange students on the courses relevant to each student's programme of studies.
- (d) Ensure that exchange students will receive the same instruction, be subject to the same course requirements and be assessed in the same manner as the students from the host institution. Students studying under this programme will be accorded the same rights, privileges, and access to facilities as other international students at the host institution.
- (e) On completion of a student's course of study, forward an official transcript (and eventual diploma) to the student and/or the home institution.
- 8.2 Credit for courses taken will be transferred at the discretion of the home institution in accordance with its policies and procedures.





#### 9. STUDENT SUPPORT AND OBLIGATIONS

- 9.1 The host institution will provide exchange students with assistance (including assistance with finding suitable accommodation) on arrival, orientation and ongoing support services throughout the period of enrolment. However,
- 9.2 The institutions acknowledge and agree that:
  - (a) All exchange students must abide by the laws of the host country and the regulations, rules and policies of the host institution; and
  - (b) All exchange students must comply with the requirements of their student visa, including student status, attendance and participation in all learning activities and all other applicable rules and regulations.
- 9.3 If any of the exchange students studying at the host institution are unable to continue their studies, as soon as practicable after becoming aware of this, the host institution will advise the home institution and provide relevant details.
- 9.4 Exchange students who fail to abide by the requirements of clause 9.2 may be subject to disciplinary action and may be required to leave the host institution. If any exchange student is subject to disciplinary action or required to leave the host institution, the host institution will advise the home institution and provide relevant details as soon as practicable.

#### 10. STUDENT VISA AND HEALTH INSURANCE REQUIREMENTS

- 10.1 The institutions acknowledge and agree that each exchange student will be responsible for obtaining a visa and other related documents required for study at the host institution. The host institution gives no warranty that any student will be entitled to an appropriate visa, but the host institution will provide incoming exchange students with such valid certification as may be required to obtain a student visa for the full period of the exchange.
- 10.2 The institutions acknowledge and agree that each exchange student will be required to carry an adequate policy for travel and health insurance (including repatriation) that is satisfactory to the host institution for the full period of the exchange and provide proof of this to the host institution upon request.
  - (a) All exchange students from UV who are under 28 years old and staying for more than three months are required to subscribe to the French Health Insurance system for the duration of their studies in France. Further, they are required to enrol in a private health insurance plan in their own country, before applying for their student visa.
  - (b) All exchange students from UV who are 28 years or older on September 30th of the ongoing academic of exchange should have a proof of health insurance covering the duration of his or her stay in France.
  - (c) All exchange students (EU-students) from KEDGE BS need a valid European Insurance card or proof of membership in a recognized health insurance (for the whole study period in Valencia) with the enrolment in Valencia. Non-EU students must be insured





with a Spanish health insurance company. All students under the age of 30 may register with a Spanish public health insurance at the current student rate.

#### 11. FINANCIAL ARRANGEMENTS

- 11.1 Each institution will waive the registration and tuition fees for exchange students. The institutions acknowledge and agree that other fees such as course materials fees or computer use fees or fees for free public transportation may be required of exchange students by the host institution. The institutions acknowledge that each exchange student shall pay all required tuition and educational fees to her or his home institution.
- 11.2 The institutions acknowledge and agree that all other costs, including travel, accommodation, health insurance, textbooks, passport and visa costs and living expenses are the personal responsibility of the student.

#### 12. GENERAL PROVISIONS

- 12.1 This Agreement comes into effect when signed by both institutions (or the date of second signature in case of delayed signatures).
- 12.2 This Agreement will continue for a period of four (4) years.
- 12.3 Either party may at any time decide to terminate the Agreement by informing the other party within a reasonable time so as not to prejudice the mutual interests of the two institutions or the students involved in the exchange. A written notice of six months period is recommended.
- 12.4 The duration of the Agreement can be extended once more by equal period at the initiative of any of the parties, prior written agreement, before the date of its conclusion.
- 12.5 In the case of termination, students who have already been notified of acceptance by the host institution shall be allowed to undertake and complete the student exchange in accordance with the terms of this Agreement.
- 12.6 All questions or disputes related to the interpretation or implementation of this Agreement shall be settled by a mutually agreed-upon third party arbitrator.
- 12.7 The provisions of this Agreement may only be amended by mutual Agreement in writing and signed by the authorised representative of each party.
