UNIVERSITÀ DEGLI STUDI DI BRESCIA AND UNIVERSITAT DE VALÈNCIA
-DUAL DEGREE ARTICULATION AGREEMENT -**

BY AND BETWEEN

Parties:

Università degli Studi di Brescia, hereinafter also referred to as UNIBS, located at Piazza del Mercato, 15 25121 Brescia, Italy, and represented by Prof. Francesco Castelli, title Rector, under the powers of the Statutes of the University of Brescia by D.R. n. 68, 2nd december 2011; with full powers in regard to this Agreement

and

Of the one part, the Universitat de València Estudi General (hereinafter referred to as UV), with legal address at Avinguda de Blasco Ibáñez, 13, 46010 Valencia, with fiscal identification number Q-4618001-D and represented herein by its rector, Ms María Vicenta Mestre Escrivá, acting by virtue of Article 94 of the Statutes of the Universitat de València, which were approved by Decree 128/2004, of 30 July, of the Consell de la Generalitat (DOGV 2004/8213), amended by Decree 45/2013, of 28 March, of the Consell (DOGV 2013/6994) and entitled to enter into this agreement by virtue of her appointment by Decree 25/2022, of 11 March, of the Consell (DOGV 2022/9297).

The parties to this agreement hereby

DECLARE

- I. That on 29 June 2018, the parties signed a collaboration agreement for Dual Degree Programme (University Degree in Management and Business Administration from UV and the Bachelor in Economia e Gestione Aziendale from UNIBS) which came into force on 1 September 2019.
- II. Clause XIV of the agreement offers the parties the possibility of amending it by written agreement.
- III. The clause X of the aforementioned agreement provides that the parties may decide to extend the agreement by express consent.

The parties, acting in their aforementioned capacities, acknowledge the other's legal capacity to modify and extend the agreement according to the following



CLAUSES

ONE.- AMENDMENT OF THE AGREEMENT

In the clause VIII, "Degree Requirements" say:

"[...]

1. In order to achieve the Laurea in Economia e Gestione Aziendale (EGA-Amministrazione e Controllo) - UNIBS, UV students must complete (details included in the Annex 1 to this agreement) at least 240 ECTS, including 120 ECTS awarded by UNIBS.

2. In order to achieve the Degree in Management and Business Administration from UV, UNIBS students must complete at least 240 ECTS, including the credits awarded by UV (details included in the Annex 1 to this agreement).

[...]"

The parties agree that say:

"[...]

1. In order to achieve the Bachelor in Economia e Gestione Aziendale (EGA-Amministrazione e Controllo) plus certification of the first year Master in Consulenza Aziendale e Libera Professione (CALP) from UNIBS, UV students must complete (details included in the Annex 1 to this agreement) at least 240 ECTS, including 120 ECTS awarded by UNIBS.

2. In order to achieve the Grado en Administración y Dirección de Empresas from UV, UNIBS students must complete at least 240 ECTS, including the credits awarded by UV (details included in the Annex 1 to this agreement).

TWO.- EXTENSION OF THE AGREEMENT

The parts approve an extension for the agreement signed by the parties on 29 June 2018 for the double degree programme in Management and Business Administration from UV and the Bachelor in Economia e Gestione Aziendale from UNIBS which came into force on 1st September 2019.

The validity of the agreement is extended for four more years.

THREE.- TERMS OF THE EXTENSION

This extension is signed while maintaining the other terms and conditions set out in the agreement signed in 2018.
