Basic characteristics of social protection system are contained in this article, as a part of Welfare State, just as it is developed in *Comunidad Valenciana* (a Spanish region), although using as references the rest of regions and the whole State. It contains also an analysis of its evolution during the last decade. It is a summary of a more extensive work elaborated with the design and development of a social protection indicators system. The object of the article is double: the analysis of Social Security system (pensions and benefits) and the Social Services system (both general and specific services). The results of the analysis draw that our protection level is generally under the average of Spain, although in several cases, a few of them, improve the national average.

THE "KNOWLEDGE SOCIETY": A THEORETICAL REWIEW OF A POSSIBLE MODEL DEVELOPMENT FOR LATIN AMERICAN

The aim of this paper is to show some of the theories about the "Knowledge Society" and to discuss its pertinence for Latin American reality. In particular, I am interested in showing that the transformation of an explanatory theory into a model of development, has been taking place through the selection of the less problematic features of the theoretical corpus. Conflicts that derive from the private appropriation of knowledge and their effects on social inequality —mostly among countries and regions, but also among individuals in societies—are often dismissed. While evaluating as positive the accumulation of abstract knowledge itself, this is an attempt to show some of the negative aspects of its dynamics, in order to prevent their worst effects on human development in Latin American countries.

WEAVING DISSIDENTS: A FOCUS ON THE GENDER TRANSFORMATIONS IN THE VOLUNTARY FIELD This article is placed within the discussion concerning citizenship participation and voluntary from a gender point of view. The available data show that among the voluntary organizations, women work on those less prestigious tasks or with a lower social visibility. Besides, the unequal co-operation in the managing

positions of these entities, according to men and women is conditioned on the social gender adscriptions, the varied use of time and the unequal distribution of home jobs - unpaid family jobs. The findings that we show point out a first approach to the discursive representations related to the gender, which are related to these questions, worked on discussions groups in Valencian entities of social voluntarism.
