Aniceto Masferrer is Professor of Legal History and teaches legal history and comparative law at the Faculty of Law, University of Valencia, Spain. He has been a fellow researcher at the Institute Max-Planck for European Legal History (2000-2003), Visiting Professor at the University of Cambridge (2005), Visiting Scholar at Harvard Law School (2006-07) and at Melbourne Law School (2008), and Visiting Professor at the University of Tasmania (2010), Visiting Scholar at Louisiana State University – The Paul M. Hebert Law Center – (2013), Visiting Scholar at George Washington University Law School (as the Recipient of the *Richard & Diane Cummins Legal History Research Grant for 2014*), and Visiting Professor at the *École Normale Supérieure* – Paris (2015), *Center for Advanced Study*, CAS, Oslo (2021, 2022), Università degli Studi Roma Tre (2022), Università degli Studi de Bari Aldo Moro (2023), Harvard Law School (2024). He has lectured at universities around the world (France, Germany, Belgium, The Netherlands, Malta, Israel, United Kingdom, Sweden, Norway, USA, Canada, Australia and New Zealand).

He is the author of ten books (including his *Spanish Legal Traditions. A Comparative Legal History Outline*, Madrid, 2009; 2012, 2nd ed.; *The Making of Dignity and Human Rights in the Western Tradition. A Retrospective Analysis*, Springer, 2024) and the editor of fifteen (including *Post 9/11 and the State of Permanent Legal Emergency: Security and Human Rights in Countering Terrorism*, Springer, 2012; *Counter-Terrorism, Human Rights and The Rule of Law. Crossing Legal Boundaries in Defence of the State*, Edward Elgar Publishing, 2013; *Human Dignity of the Vulnerable in the Age of Rights: Interdisciplinary Perspectives*, Springer, 2016; *The Western Codification of Criminal Law: The Myth of the Predominant French Influence in Europe and America Revisited*, Springer, 2018; *Comparative Legal History*, Edward Elgar Publishing, 2019; *Criminal Law and Morality in the Age of Consent: Interdisciplinary Perspectives* Springer, 2020), and more than hundred book chapters/articles published in Spanish, European and American law journals. He has published extensively on criminal law from an historical and comparative perspective, as well as on the codification movement and fundamental rights in the Western legal tradition.

He has participated in several international research projects and has been the main researcher of several research projects (for example, on “Security and Human Rights in countering terrorism from a historical and comparative perspective,” which involved more than thirty scholars from several universities (Spanish, European, Northern-American, Canadian and Australian universities), and whose results were published in three collective monographs, coordinated by himself (and edited by Aranzadi-Thomson Reuters 2011; Springer 2012; and Edward Elgar Publishing 2013). Currently, he is leading a research project (financed by Economics and Competitiveness Ministry) on the foreign influences in Spanish Codification of criminal law (ref. DER2012-38469; DER201678388-P; PID2019-105871GB-I00).

He is author of five books for teaching purposes, being coeditor of *A Companion to Western Legal Traditions: From Antiquity to the Twentieth Century* (A. Masferrer, C.H van Rhee, and S.P. Donlan, C. Heesters, eds.), Brill, 2023. In 2010 he received the award ‘Teaching Excellence’ (which is annually granted by the Valencian Government to the best university lecturer).

He writes opinion articles in both local and national newspapers (*ABC*, *El Mundo y Las Provincias*) and has published five books for a general audience: *Para una nueva cultura política* (Catarata, 2019), *Manual de ética para la vida moderna* (EDAF, 2020), *La eutanasia en España. Perspectivas desde la vulnerabilidad* (Rialp, 2021), *Libertad y ética pública. Por qué pensar críticamente es clave para salvar la democracia* (Almuzara, 2022); y *Cómo vivir en libertad siendo uno mismo* (Grupo Editorial Fonte, 2024).

He is a member of the advisory board of several Spanish, European and Anglo-American Law Journals, and the Chief Editor of *GLOSSAE. European Journal of Legal History* (<http://www.glossae.eu>). He is member – and former president – of the *European Society for Comparative Legal History* (2010-2018), and vice-president of the *Fundación Universitas* (www.fundacionuniversitas.org). He is also the Director of the *Institute for Social, Political and Legal Studies*, member of the Spanish *Royal Academy of Jurisprudence and Legislation*, and board member of the *Valencian Committee for European Affairs*.
