He has also participated as a researcher, in some cases, and as a responsible researcher, in others, in 9 OTRI collaboration contracts with different public and private organizations.

He has published papers in journals such as Entrepreneurship & Regional Development, Journal of Business Research, Service Business, Service Industries Journal, Management Decision, Baltic Journal of Management, Journal of Business Economics and Management, Sustainability, International Entrepreneurship and Management Journal and Competitiveness Review, among others.
