

CHECKLIST DEPOSIT AND ADMISSION TO PROCESSING OF THE DOCTORAL THESIS

This document contains a checklist to verify the requirements to be met in the deposit of a doctoral thesis under the [2024 Deposit Regulation](#). It is a work tool that must be considered by the CAPD before deposit.

Given the peculiarities of theses with mention and by compendium, a specific list is included to be used in each type as appropriate.

Before admission for processing, it must be verified that ALL the requirements are met.

	Cover: coat of arms of the UV, program's name, title of the thesis, name of the doctoral student and supervisors, month and year of deposit.	
	Thesis written in a NON-official language: abstract of at least 5000 words in an official language (objectives, methodology and conclusions).	
Proposal for a Tribunal	List of 6 experts (3 full - 3 alternates) with gender equality/parity.

If it has been carried out without competitive funding , it has been requested and received the approval of the Doctoral School.		
Thesis PDF	Resumen/Resum/Abstract thesis of at least 4000 characters in English, Spanish and Valencian. Note: In addition to these summaries, an abstract of a maximum of 3000 characters for deposit by entreu .	
	Structure: introduction, objectives, methodology, results, conclusions, bibliographic references.	
	Cover: coat of arms of the UV, program's name, title of the thesis, name of the doctoral student and supervisors, month and year of deposit.	
	Language of the thesis. 	Minimum 2 experts from non-Spanish institutions with stable links to their institution for at least 3 years . Cannot be responsible for the doctoral student's stay.	
	A maximum of 2 members from the same Institution and the same Doctoral Programme , divided where appropriate between the full and alternate tribunals.	
	Experts with 1 six-year term or 5 contributions (3 indexed publications at least with indication of quality indices) in the last 10 years.	
	President with the highest academic rank and seniority.
