



# **RESOLUTION of 14th December, 2020, of the dean of the Faculty of Economics of the** University of Valencia, by which the call and the regulatory bases of the II PRIZE 'INTERNATIONAL MOBILITY FdE #ORIFdE2021' Faculty of Economics is made public. University of Valencia.

The dean of the Faculty of Economics of the University of Valencia, making use of the powers conferred by the resolution of 19th June,2019 of the Rectorate of the University of Valencia (DOGV of 27th June, 2019), by which approves the delegation of functions to the vice-chancellors, the general secretary, the manager, and other bodies of this university.

#### RESOLVE

#### **First**

Approve the call and the regulatory bases of the II PRIZE 'INTERNATIONAL MOBILITY FdE #*ORIFdE2021*' Faculty of Economics. University of Valencia, included as an annex to this resolution.

#### Second

The respective file contains the adequate and sufficient budgetary allocation to meet the expenditure liabilities that may arise from this call. The award is financed based on the Chapter IV of the budget of the University of Valencia for 2020, organic 3050000000, for an amount of 425.00 euros. Prizes consist of a first award of 150 euros; a second prize of 100 euros; a third prize of 75 euros; and two second prizes of 50 euros.

#### Third

Against this resolution, which exhausts administrative proceedings, an appeal for reversal can be filed within a period of one month, from the day following its publication, before the same body that issued it, or directly a contentious-administrative appeal, before the bodies of the contentious-administrative jurisdiction of the Valencian Community, within a period of two months from the day following its publication.

# ANNEX I. BASES OF II PRIZE 'INTERNATIONAL MOBILITY FdE'. OFFICE OF INTERNATIONAL RELATIONS OF THE FACULTY OF ECONOMICS. UNIVERSITY OF VALENCIA.

## **1. OBJECT**

The object of this contest is reward the best photographs that show the'EUROPEAN FEELING' during the college mobility (Erasmus Program or International Program). Photographs taken by students of the Faculty of Economics, both incomings and outgoings, during the 2020-2021 academic year and which present them as candidates following the instructions that are detailed below.

This award is compatible with other grants, aid, income or resources for the same purpose.

#### **2. PARTICIPANTS**

Students of the Faculty of Economics of the University of Valencia, both outgoing and incoming, that in the 2020-2021 academic year are udertaking or have carried out an European or international university mobility and who have an account on Facebook, Twitter, or Instagram with a public profile and that respect the terms of use of these social networks, can participate.

# **3. CONDITIONS OF PARTICIPATIONS**

3.1. Candidate photographs will be submitted in accordance with the requirements indicated below:

- a) Each participant may only submit one photograph.
- b) Photographs sent as candidates have to be **original** and have not been awarded previously.
- c) Photos of minors and recognizable people that have advertising, political, and/or religious references will be excluded. The images do not have to violate the rights of third parties nor can they represent third parties who should be asked for their consent and authorization.
- d) The subject has to deal with any aspect related to the 'European feeling experienced during a mobility or an university exchange'. There can be many examples from day to day that show this European feeling (respect, effort to improve, fellowship,etc.)

#### 3.2. The way of participation and submission is as follows:

a) The candidates have to post on Facebook, Twitter or Instagram a photograph that show the European feeling during their Erasmus or International mobility carried out or that they are undertaking during the 2020-2021 academic year.

- b) The candidates must always mention or allude to the Faculty of Econmics. The institutional accounts of the Faculty of Economics are as follow:

- c) The photo has to be published with the hashtag #ORIFdE2021, tag the Faculty of Economics and put a brief title in order to identify the photo.

Any photogrph that is submitted outside the establised cannel or after the submission deadline will not be taken into account. Likewise, if it does not comply with the stipulations contained in these bases, it will not be accepted and will not participate in the prize.

Winning photographs will be kept at the Faculty of Economics. The photographs that are not awarded may not be erased or eliminated from the Faculty's databases until the prizes have been granted and the deadlines for filing appeals referred to in point 12 of this resolution have expired.

## 4. DEADLINE FOR SUBMISSION

Photographs can be submitted from the day after the publication of the extract of this resolution in the Official Journal of the Generalitat Valenciana (DOGV) and **until 30th** April, 2021 at 2:00 p.m.

## **5. CONCESSION PROCEDURE**

The concession procedure will be the competitive concurrance regime in accordance with section 1 of chapter II of Law 1/2015, of the Generalitat, of public finances, of the instrumental public sector and of subsidies.

The concession resolution will be made within a máximum period of six months from the publication of the call, according to what is established in article 25 of Law 38/2003, of 17th November, general of subsidies.

## 6. AWARD

The respective file contains the adequate and sufficient budgetary allocation to meet the expenditure liabilities that may arise from this call. The award is financed by Chapter II of the budget of the University of Valencia for 2020, organic 3050000000, for an amount of 425.00 euros.

The prizes consist of a first prize of 150 euros; a second prize of 100 euros; a third prize of 75 euros; and two second prizes of 50 euros.

## 7. JURY AND ASSESSMENT CRITERIA

At the end of the period for submitting the photographs, the jury, made up of two people from the international relations office of the Faculty of Economics and a representative of the secretary of the Faculty of Economics, University of Valencia, will make a first shortlist of 10 photographs.

These 10 shortlisted photographs will be published on the official Instagram account of the Faculty of Economics with **# ORIFdE2021** so that all friends, acquaintances and, ultimately, interested people can vote for the photograph they like the most, giving a "like" to their favorite photo. The photograph with the greater number of "likes" will be the winner of the contest.

Likewise, the 10 photographs will be exhibited in the hall of the Faculty of Economics of the University of Valencia from May 3 to 21, 2021. From the Faculty of Economics it is possible that they will contact the shortlisted candidates, by email, with the purpose of requesting the photos in order they do not lose quality.

The deadline for voting online through Instagram will be from May 3 to May 21, 2021 at 2:00 p.m.

The jury that is appointed for this purpose has the power to interpret and resolve any circumstance not planned in these bases, for a better fulfillment of the objective of the award. The composition of the jury will be published on the website of the Faculty of Economics and on the website of the ORI-FdE.

The jury of the contest will assess the photographs presented, mainly attending to the ability **to capture and generate empathy** through the image presented. Image that will have to refer to situations that generate or contribute to disseminate the underlying values in the Erasmus+ program (respect, solidarity, effort to improve higher education, etc.). In addition to this, the jury will also value the quality of the photograph presented.

Prizes may be declared void if, at the criterion of the jury who have to make the first preselection, none photograph has the necessary merits to be awarded.

# 8. RESOLUTION OF THE PRIZE

Once the deadline for online voting is over, as shown in base 7, the jury will submit a concession proposal to the dean of the Faculty of Economics, who will decide on the awards.

The concession resolution will be published on **June 1, 2021**, for notification purposes, on the official notice board of the University of Valencia (https://tauler.uv.es) and will be communicated to all finalists via email.

The dean of the Faculty of Economics of the University of Valencia is responsible for the processing of this procedure.

The dean of the Faculty of Economics of the University of Valencia will decide the grant of the prize considering the award proposal made by the jury, which will assess the results obtained in the online voting through the Instagram of the Faculty of Economics, according to the criteria indicated in base 7.

The bases of this call will be published on the official notice board of the University of Valencia (https://tauler.uv.es), on the website of the Faculty of Economics (http://www.uv.es/ economia), on the website of the Office of International Relations of the Faculty of Economics (https://www.uv.es/uvweb/economia/ca/mobilitat-intercanvi/ori-facultat- economia / valencia-erasmus-week) and in other means that may be considered adequate. Subsequent communications with the postulated candidates will be made via email.

## **10. SUPPLETIVE RULES**

In addition, Law 1/2015, of February 6, of the Generalitat, on public finance, the instrumental public sector and subsidies, and Law 39/2015, of October 1, on the common administrative procedure of public administrations will be suitable.

Likewise, Law 34/2002, on services of the information society and electronic commerce (LSSI), regarding the way of offering information on internet; Organic Law 3/2018, of December 5, on the protection of personal data and guarantee of digital rights; Legislative Royal Decree 1/1996, of April 12, for which the revised text of the Intellectual Property Law is approved, depending on the subsequent purposes of the promotion; Organic Law 1/1982, of May 5, on civil protection of the right to honor, personal and family privacy and self-image.
