#### Global Responsibility Week 2022 - 'Net Zero is the New Normal'

Nottingham Business School (NBS) at Nottingham Trent University will be holding its annual 'Global Responsibility Week' during the week commencing 4th April 2022 and we would very much appreciate it if you or members of your faculty would consider taking part.

Following the UK's hosting of COP26, we are particularly focused on how business can respond to the climate pledge of targeting net zero by 2040, or as Steve Howard, Co-Chair and Co-Founder of the *We Mean Business Coalition* expressed, making 'net zero the new normal'. This will require effective leadership in achievement of the UN's Sustainable Development Goals (SDGs) alongside ambitious plans for reducing emissions, supporting sustainable innovation, working with stakeholders, improving sustainability reporting and engaging investors in implementation. We would welcome proposals which develop our students' understanding of and sensitivity to these challenges as they enter a world in which businesses worldwide have committed to the UN's Business Ambition for 1.5°C.
