

ERASMUS INTERNSHIP GRANT

For OUTGOING students with biannual or annual mobility periods:

The Erasmus Internship Grant call has three annual deadlines. The requirements, besides the ones detailed in the call, are the following:

- It can't overlap with another studying mobility, not even a month.
- The student must be enrolled in a traineeship in the UV the same year.
- The Faculty of Economics doesn't allow to include internships in the Learning Agreement. Therefore, is quite difficult to combine studies and internship the same year, unless it's a fourth-year student and only went with Erasmus in the first semester.
- Their own degree regulations must allow this type of internship mobility.

For OUTGOING students of the International Double Degree (IDD):

The call for Erasmus Internship sets the following requirements for students:

- No previous Erasmus mobility for 12 or more months.
- Be enrolled in an official degree programme with internship courses within the academic offer.
- Haven't previously passed the Internship course in the degree.
- Have a vacancy assigned by the Internship Committee of the host university.

Outgoing students from the International Double Degree will study the third year in a foreign country with an annual Erasmus mobility and are registered as outgoing students at the University of Valencia. They will study abroad the fourth year as International Double Degree students of second course with a 1.000€ grant and are registered as second-year outgoing students at the University of Valencia.

Therefore, there is no chance to apply for Erasmus Internship Grant because:

- Erasmus mobility is usually less than 10 months, so they only have left a two-month credit in the degree for the Erasmus application.
- They could think that there is time left to do the two-month Erasmus Internship during the fourth year, but this isn't possible because the programme is measured as staying months, both the granted and the non-granted period. Therefore, any internship mobility longer than two months will not be authorized.
- Every internship of IDD Outgoing students exceed the two-months period mobility due to the number of ECTS credits in their degree programme. In conclusion, there is no time to do altogether the annual Erasmus mobility and the biannual Erasmus Internship due to the 12 months limit that the Erasmus programme regulates for bachelor's degrees.

For INCOMING students of the International Double Degree (IDD):

IDD Incoming students enroll at the UV the first year (also second or third year, depending on their home university) with an Erasmus study grant and are registered as incoming students in the UV. They will do the second year (or third or fourth) in the UV without Erasmus grant and are also registered as incoming students of the UV.

Therefore, there is no chance neither to apply for Erasmus Internship Grant because:

- They are registered as Incoming UV students so they can't apply to the Erasmus Internship Grant.
- The Erasmus studying mobility usually lasts 10 months, so they only have left a two-month credit in the degree period for the Erasmus application. The same student may participate in mobility periods totaling up to 12 months of physical mobility maximum per each year of study, even in other higher education institutions. The Erasmus+ Programme guide remarks: *"Prior experience under the Erasmus+ Programme and/or as Erasmus Mundus scholarship holders counts towards the 12 months per study cycle."*
- Every internship offered to double degree incoming students exceed this period due to the number of ECTS credits of their degree.
