## LAST CALL FOR PAPERS

This International Congress is organised by the ETICCs Research Group of the University of Valencia, within the framework of the "subvenciones para la organización y difusión de congresos (CIAORG), de la Conselleria de Educación, Universidades y Ocupación de la Generalitat Valenciana".

The aim of the conference is to address the various issues raised by the process of economic digital transformation and globalisation in the development of international tax systems and standards in the 21st century.

The attached programme will be developed around different round tables in which (a) the scientific community, (b) representatives of state administrations, international organisations and companies, and (c) professionals from the sector, can find a meeting point and dialogue in which the possible lines of evolution of tax systems in the 21st century can be debated.

Proposals for papers may be made in Spanish or English, and must fall within one of the following subject areas:

- Updating ability to pay situations: new taxable events.
- Adaptation and updating of tax systems: ways of improvement.
- Extraordinary taxes and complementary taxes.
- International tax standards. Adaptation and evolution.
- International and interjurisdictional equity and redistributive justice.

- Global tax governance.
- Pillar 1, Pillar 2, Digital Services Tax: evolution and implementation problems.
- Comparative tax systems: proposals for adaptation.

- Title of the paper
- Abstract (500-700 words)
- Thematic area in which it is framed
- Author's name and surname, e-mail address and institutional affiliation.

On 15<sup>th</sup> October 2024, applicants will be informed by e-mail which papers have been accepted by the Scientific Committee. Accepted papers will be presented during the congress and will be published with the rest of the reports and conclusions in the subsequent collective work. The final version cannot exceed 20 pages (Times New Roman, 12pt., space and a half) and must be sent by email before 30<sup>th</sup> November 2024 to the following address: tax@uv.es
