Mobility - Facultat de Farmàcia i Ciències de l'Alimentació

1. Maximum duration of mobility

- 1.1. Students enrolled in the Bachelor's Degree in Pharmacy and in the Double Degree in Pharmacy and Human Nutrition and Dietetics may complete a maximum of one full academic year under the ERASMUS or International Programme, and one full academic year under the SICUE Programme, independently.
- 1.2. Students of the Bachelor's Degrees in Human Nutrition and Dietetics, Food Science and Technology and Gastronomic Sciences, may complete a maximum of one academic year of mobility during their studies, whether through the ERASMUS Programme, the International Programme, the SICUE Programme, or a combination thereof.

2. Enrolment limit at the host university

Students participating in a mobility programme for one academic year may enrol in a maximum of 60 ECTS credits, or the equivalent number of credits according to the host university's system corresponding to 60 ECTS at the University of Valencia. In the case of Double Degree students in Pharmacy and Human Nutrition and Dietetics, the total number of credits may reach up to 66 ECTS, or the equivalent number at the host institution.

3. Incompatibility with additional enrolment at the UV during annual mobility If a student is enrolled in 60 ECTS credits in their mobility programme (equivalent to a full academic year), they may not simultaneously enrol in additional subjects at the Faculty of Pharmacy and Food Sciences during that same period. If the enrolment at the host university is lower than 60 ECTS, it may be completed up to that limit with courses from the Faculty of Pharmacy and Food Sciences, provided academic and in-person attendance requirements can be adequately met.

4. Compatibility for semester mobilities

If the mobility period covers only one semester, enrolment in semester-long courses at the University of Valencia will only be permitted if it is fully compatible with compulsory attendance to in-person activities required by the faculty. No exceptions will be made to this rule.

5. Examinations of UV subjects

Under no circumstances will examinations for subjects enrolled and taken at the Faculty

of Pharmacy and Food Sciences of the University of Valencia be permitted to be completed at other universities.

6. Verification of admission at the host university

Students applying for participation in an international mobility programme must verify in advance that the host university accepts students for the degree they are currently pursuing at the University of Valencia. The faculty shall not be held responsible for any denial of admission by the host institution resulting from the failure to carry out this verification.

7. Reminder of the credit recognition regulations

Students are reminded that course recognition will be carried out in accordance with the Regulations on Credit Recognition of the University of Valencia, considering the equivalence of content, teaching load, and number of credits.

Grades will be converted according to the official grade conversion table approved by the university, recalculated based on any difference in credit value, if applicable, and following the academic criteria established by the institution.
