Scientific Conference

With a long tradition, debates on living standards have experienced a notable resurgence in recent decades thanks to contributions that have significantly expanded theoretical and methodological approaches to this fascinating topic. Thus, research has definitively shifted towards the quantitative exploration of price and wage trends to estimate the purchasing power of the population.

Medievalists and modernists have incorporated these approaches, originally applied to industrial societies, into their work. Combined with traditional methods of study, they were to make a significant contribution to a period characterised by increased production and circulation of consumer goods. In this way, historiography has highlighted the sustained growth in living standards in Western Europe since the early stages of the late medieval crisis, a process often linked to the growth of real wages. However, the growing disparity of this phenomenon has also become apparent since the so-called "price revolution", when a differentiation in the broad trends of prices and wages took place, constituting one of the decisive aspects of what is known as the "small divergence".

For this reason, the Doctoral School will address the latest research on living standards, with a special focus on training doctoral students and young doctors in theoretical and methodological aspects. Presentations and papers will be the essential mechanism for understanding living standards and the socio-economic complexities of the medieval population, thus offering a more complete view of how these aspects were intrinsically linked to everyday life and social structures.
