

Resolution of 20 June 2019, by the Office of the Principal of the Universitat de València, which makes a public call for the provision of positions for the internal promotion of full university professors listed in Annex I. Call 138 / 2019

TEXT:

In compliance with the provisions set out in the second paragraph of Article 62.2 of Organic Law 6/2001, of 21 December, on universities, Royal Decree 1312/2007, of 5 October (Official State Gazette of 6 October) and Royal Decree 1313/2007, of 5 October (Official State Gazette of 8 October), regulating national accreditation and the competitive selection process for university teaching staff positions respectively, and in accordance with the provisions of Article 3 on the Recruitment Regulations for UV Teaching and Research Staff, approved by the UV Governing Council dated 27 May 2003, with amended wording by agreement of the Governing Council dated 23 December 2008, and subsequent revisions.

The Office of the Vice Principal, in accordance with the 2019 Offer of Public Employment, regarding university teaching staff and tenure-track 2 professors at the Universitat de València, published in the Official Gazette of the Valencian Government dated 23 May 2019, with prior authorisation by the Ministry of Education, Research, Culture and Sports, in compliance with Article 19, section One.3.I) and 4, of Law 6/2018, of 3 July, on the 2018 General State Budget, has resolved to make a public call for the positions listed in Annex I of this resolution. These positions have been included in the UV budget and are subject to the following terms and conditions:

Terms and Conditions

1. General regulations

1.1 The calls will be regulated by the provisions set out in Article 62.2 of Organic Law 6/2001, of 21 December, on universities modified by Royal Decree Law 10/2015, of 11 September (Official State Gazette of 12 September 2015) and the concordant precepts of the Organic Law on Universities (LOU); Law 7/2007, of 12 April, on the Basic Statute for Public Employees (Official State Gazette of 13 April); Royal Decree 1312/2007, of 5 October (Official State Gazette of 6 October) and Royal Decree 1313/2007, of 5 October (Official State Gazette of 8 October), regulating national accreditation and the competitive selection process for university teaching staff positions respectively; Decree 128/2004, of 30 July, by the Valencian Government, approving the UV Statutes (Official Gazette of the Valencian Community of 3 August); the Recruitment Regulations for UV Teaching and Research Staff, approved by the UV Governing Council of 27 May 2003, and subsequent modifications as well as the terms and conditions of this call. In situations in which there are no previous regulations, the following shall be applied: Law 39/2015, of 1 October, on the Common Administrative Procedure of Public Administrations (Official State Gazette of 2 October 2015); Law 40/2015, of 1 October, on the Common Administrative Procedure of Public Administrations (Official State Gazette of 2 October 2015) and the General Legislation on Civil Servants.

2. Candidate requirements

In order to be admitted to each selection process, the following requirements must be met:

2.1 General requirements

- a) Have Spanish or EU nationality or be a citizen from a country that, in virtue of international treaties entered into by the European Union and ratified by Spain, follows freedom of movement for workers. A spouse, descendants, descendants of spouses, descendants of Spaniards and descendants of EU nationals may also apply provided that the spouse is not separated or legally separated. Descendants must be under 21 years old or may be older if they are still claimed as dependents. This will be equally applicable for family members of other nationalities as stipulated in the international treaties entered into by European Union and ratified by Spain. Likewise, citizens may participate if they are from non-EU countries where Spaniards are recognised as having the legal aptitude to occupy a university teaching position which is similar to a civil servant teaching staff position in Spanish universities.
- b) Not to have reached the maximum mandatory retirement age established by current legislation by the application deadline.
- c) Have a PhD degree.
- d) Not to have been disqualified from public service or from the constitutional or statutory bodies of the Autonomous Communities, or to have been subject to any disciplinary proceedings leading to the dismissal from any public administration post or the selection process for public employment.
- e) Have the functional capacity to carry out tasks corresponding to university teaching staff.
- f) Have paid the exam fees established in this call or have proof of exemption or discount.

2.2 Specific requirements

Be a civil servant tenured university professor or scientific researcher at a public research entity, and have worked for a minimum of two years under this status. Be accredited for the full university professor staff in accordance with Royal Decree 1312/2007, of 5 October. Accreditation received after the modification introduced by Royal Decree 415/2015 must be from the same branch of knowledge corresponding to the area of knowledge in this call, in accordance with Annex I of Royal Decree 1312/2007.

Candidates are deemed to have the accreditation regulated by Royal Decree 1312/2007, of 5 October if they are qualified in accordance with Royal Decree 774/2002, of 26 July, which regulates the national qualification system for civil servant university teaching staff positions and the regulations for respective calls.

2.3 All of these requirements must be met by the application deadline and maintained until the candidate has formally accepted the position.

3. Applications. Submission deadline

3.1 Those who wish to participate in the competitive selection process must send their application to the Office of the Principal of the Universitat de València addressed to the Human Resources Service (Teaching and Research Staff/calls) at Avda. Blasco Ibáñez, 13, 46010, Valencia, via the UV Registry Office or via any of the procedures set out in Article 16.4 of Law 39/2015, of 1 October, on the Common Administrative Procedure of Public Administrations. The application form attached in Annex II must be completed and sent with the following supporting documents that comply with the requirements to participate in this call:

a) Photocopy of the national identity document or passport. Candidates who do not have Spanish nationality but who have the right to participate must submit a verified photocopy of the document that proves nationality and, if applicable, the documents that prove the family relationship and the dependency circumstance referred to in point 2.1.a (General requirements). Likewise, when the candidate is a spouse, he/she must also submit a signed declaration stating they have not separated.

b) Originals or verified photocopies of certifications that accredit compliance with the requirements listed in point 2 (Candidate requirements) to participate in the competitive selection process. Doctoral degree certificates issued by the Universitat de València do not need to be submitted.

In order to verify nationality and other requirements, candidates must submit supporting documents certified by the competent authorities of the country of origin. These documents must be translated into Spanish, which is the official language used in the exams.

c) Proof of having paid the exam fees (€30) in the account "*Derechos de examen-Universidad de Valencia*" número ES21-0049-6721-65-2010001382 at Banco Santander. (Exam fees- Universidad de Valencia" number ES21-0049-6721-65-2010001382)

Exempt from the fees are candidates who have a recognised degree of disability of equal to or greater than 33%, members of large families (special category), members of single parent families (special category) and victims of violence against women.

Candidates mentioned in the previous paragraph must expressly prove this in the corresponding section of the application and must submit certificates that verify having a disability, being a member of a large family or being a member of a single parent family (via a certificate issued by the Department of Social Welfare or competent body). The status of being a victim of violence against women may be verified by any means of proof stipulated in Article 9.1 and 9.2 of Law 7/2012, of 23 November by the Valencian government, regarding violence against women in the Valencian Community.

A 50% discount is available for members of large families (general category) and single parent families (general category).

The application deadline will be 20 working days from the day following the publication of this call in the Official State Gazette, excluding Saturdays, Sundays and holidays.

3.2 Candidates who do not pay the exam fees by the application deadline or those who pay a lower fee will be excluded from the call. Exclusion for not complying with some of the requirements does not entail the right to a fee refund.

3.3 UV General Registry offices are open to the public from Monday to Friday. On Saturdays, applications must be submitted by other means specified in Article 16.4 of Law 39/2015, of 1 October, on the Common Administrative Procedure of Public Administrations.

3.4 Applications submitted through the post office are required to be placed in an open envelope to be officially dated and stamped before being certified, as pointed out in section b) of the aforementioned Article.

3.5 Registry offices from other universities cannot be used.

3.6 Applications from abroad may be processed through the corresponding diplomatic representations and Spanish consulates that will send them to the UV General Registry. A photocopy of the exam fee receipt is required.

3.7 The address appearing on the application is deemed the only valid one for the purposes of notifications. It is the sole responsibility of the candidate to enter the correct data and to notify a change of address.

4. Shortlisted Candidates

4.1 Within a maximum of twenty working days from the application deadline, the Vice-Principal with competencies in teaching staff will announce a resolution stating the approval for the provisional list of admitted and excluded candidates.

This resolution and the complete list of admitted and excluded candidates will indicate the reasons for exclusion, and will be posted on the UV official notice board at <https://webges.uv.es/uvTaeWeb/> and for informative purposes on the Human Resources Services (Teaching and Research Staff) website at <http://www.uv.es/uvweb/servicio-recursos-humanos-pdi/es/seleccion-del-profesorado/personal-funcionario/convocatorias-1285902899674.html>.

Within ten days from the day following publication, candidates may lodge an appeal against this resolution or rectify, if applicable, the deficiency that led to exclusion.

4.2 Within fifteen working days from the last day of the deadline for submitting and resolving appeals, the Vice-Principal with competencies in teaching staff will announce a resolution approving the final list of admitted and excluded candidates, which will be posted as previously established. An appeal for reconsideration may be lodged to the Principal within one month from the day following the publication on the UV official notice board at <https://webges.uv.es/uvTaeWeb/>.

5. Selection Committees. Official formation of committees

5.1 The selection committee members are listed in Annex I of this call.

5.2 Regulations to be followed regarding substitutions for committee members in the event of abstention, recusal or withdrawal are set out in the provisions of Article 5.2 regarding the Recruitment Regulations for UV Teaching and Research Staff.

5.3 Committees must be formed within three months from the day following the publication of the appointment of the members. After consulting with the other members, the chair will summon them and, if applicable, the substitutes to proceed to the official formation of the committee, indicating the place and date.

5.4 The official formation of each committee requires the presence of all of its members with voice and vote. The members who do not attend will no longer be able to participate in the committee and will be replaced with their substitutes. In the event of abstention, recusal or withdrawal by substitutes, the first, second and third substitute will consecutively fill in.

5.5 In the event of absences once the committee has been formed, the chair will be substituted by a member of a higher category and seniority. The secretary will be substituted by a professor with a lower category and seniority. In order for the committee to be valid, at least three of its members with voice and vote are required to participate. Committee members who are absent from any act will no longer be able to participate.

5.6 At the official formation of the committee and prior to the presentation of the candidates, specific evaluation criteria (following the criteria listed in Annex IV) for participation in the competitive selection process will be established and posted in the designated venue for the presentation of the candidates. The selection exams will have the same value. Committees cannot establish criteria that give preference to the result obtained in any of the exams.

6. Presentation of the candidates

6.1 At least fifteen days in advance, the committee chair will summon the shortlisted candidates for the presentation of the candidates by posting the date, time and place on the UV official notice board. This presentation must be held within a maximum of 5 days from the date of the official formation of the committee.

The official formation of the committee and the presentation of the candidates may take place on the same date. At this presentation, the candidates are required to give the chair five copies of their academic, teaching, research and management record (Annex III), a copy of the publications and documents supporting their merits and five copies of the teaching project (teaching guide and reasons for including the subject within the plan of studies).

6.2 At the presentation of the candidates, the committee will indicate the date of the first exam referred to in point 7 (Exams). Likewise, if applicable, the candidates' names will be drawn to determine the order and the place, date and time of the first exam. This exam must begin within a maximum of five days following the presentation of the candidates.

6.3 The committee secretary will ensure that the candidates' submitted documents may be examined by the other candidates.

7. Exams

7.1 The selection process for the internal promotion of the full university professor positions will consist of two exams. The first exam will consist of an oral presentation open to the public. It will last for a maximum of two hours and the candidate will discuss merits and his/her academic, teaching, research and management background as well as the teaching project. If the call requires a teaching profile, the project must adapt to it. Next, the committee will have a discussion with the candidate for a maximum of two hours.

Each committee member will submit an individual report specifying the candidate's performance on the first exam and then express his/her vote.

This is an elimination phase for candidates who do not obtain at least three favourable votes.

In the second exam the candidate will make an oral presentation which is open to the public for a maximum of ninety minutes on his/her research project. If the call requires a research profile, the project must adapt to it. Next, the committee will have a discussion with the candidate for a maximum of two hours.

7.2 Once the exams referred to in the preceding paragraphs have concluded, the committee or each member will submit a final detailed report, adjusted to the evaluation criteria regarding the candidate's merits and work history agreed on beforehand, and the candidate's performance in each exam.

8. Proposed candidate selection

8.1 In view of the report(s), the committee will make a proposal which must be approved by at least three votes in favour. The proposal will include a list which ranks the candidates in order of preference, without exceeding the proposed number of positions in the call. The members who vote against the majority are required to state the reason for their vote.

The committee may conclude the call without filling the position(s).

8.2 The committee's proposal will be posted on the UV official notice board at <https://webges.uv.es/uvTaeWeb/> within a maximum of 5 days from the conclusion of the exams.

8.3 Candidates may lodge an appeal to the Principal against this proposal under the terms specified in point 11 (Appeals).

8.4 The committee's proposal will remain posted on the UV official notice board at <https://webges.uv.es/uvTaeWeb/>, at least until the last day of the deadline for appeals.

8.5 Once the proposal has been made and posted, the committee chair will send it to the Principal, along with a copy of the minutes, reports and certification by the secretary of the faculty/school regarding the date of publication on the UV official notice board at <https://webges.uv.es/uvTaeWeb/>. At the end of the period for displaying the proposal to the public, the faculty/school secretary will send the certification stating the exact dates of the public display to the Office of the Principal.

9. Submission of documents

Within a maximum of twenty days from the publication of the proposed position, the selected candidate must submit the certification from the administration that they belong to, proving civil servant status and their circumstances that are stated on the list of services, except if the corresponding administration is the Universitat de València. This certification must be sent via the UV General Registry or by any other procedure pointed out in Article 16.4 of Law 39/2015, of 1 October, on the Common Administrative Procedure of Public Administrations.

10. Appointment

10.1 The Principal will appoint the candidate that has been selected by the committee after the candidate has met the general requirements. If the candidate does not submit the required documents within the designated time period, the Principal will declare the call void.

10.2 Appointments will be published in the Official State Gazette and the Official Gazette of the Valencian Government.

10.3 Within a maximum of twenty days from the day following the publication of the appointment in the Official State Gazette, the selected candidate must formally accept the position, at which time he/she will acquire the status of a civil servant full university professor.

11. Appeals

11.1 Candidates may lodge an appeal against the committee's proposal to the Principal of the Universitat de València within a maximum of ten days. Once the appeal is in process, the appointment will be suspended until its resolution.

11.2 The appeal will be evaluated by the Claims Committee, which will decide whether or not to ratify the appeal within three months.

11.3 The Claims Committee is composed of seven full university professors from diverse areas of knowledge. They are required to have received recognition for minimum periods of research activity and are appointed following the procedure set forth in Article 12 regarding the Recruitment Requirements for UV Teaching and Research Staff.

11.4 The Claims Committee will evaluate the purely procedural aspects and verify that the Selection Committee has followed equal conditions for the candidates and equal principles of merit and competencies.

11.5 Once the Claims Committee has made the proposal, the Principal will sign the resolution which exhausts the administrative procedure. Appeals must then be directly addressed to the contentious administrative jurisdiction.

12. Information regarding data

The Universitat de València is responsible for the data provided by the candidates in this process. This exclusive information will be used for the purposes of the call and, if needed, the management of staff in accordance with Organic Law 6/2001, of 21 December, on universities. All or part of this data will be published on the UV official notice board. This data will be saved indefinitely to fulfill the aims, in compliance with Law 3/2005, of 15 June, regarding the Valencian Government Archives.

Candidates have the right to access, rectify, delete, limit or oppose the processing of this data as well as the right to the portability of the data by writing to the UV Delegate for Protection of Data, accompanied by a copy of the identity card and, if necessary, documentation accrediting the application. The Universitat de València has set up an email address (lopdp@uv.es) for any information, suggestions, request for rights and amicable resolution of controversies regarding protection of personal data without prejudice to the right to appeal before the competent authority.

13. Final Regulation

Against this resolution, which exhausts the administrative procedure, an appeal for reconsideration may be lodged to the Principal of the Universitat de València within one month or a contentious administrative appeal may be lodged directly to the High Court of Justice of the Valencian Community Administrative Chamber within two months. Both time periods will start from the day following the publication of this call. If an appeal for reconsideration is chosen, the contentious administrative appeal cannot be lodged as long as the appeal for reconsideration has not been resolved or until its presumptive dismissal, in accordance with Articles 123 and 124 of Law 39/2015, of 1 October, on the Common Administrative Procedure of Public Administrations.

Participation in management tasks	15%
