TEACHING METHODOLOGY

Work Final Degree represents the climax of the student learning process that affects most directly to the development of autonomous learning ability, the ability to organize and plan and ability to make decisions and solve problems. For this classroom training activities should occupy little space force in the methodology of teaching and learning. Based on this premise, the distribution of time commitment is as follows: 1) Attendance activities (contact hours with the tutor and the evaluation committee): Tutorials: 5% (15 hours). Exhibition and oral defense: 1% (3 hours). 2) Non-contact activities: 94% (102 hours).

EVALUATION

Individual work of the student / a, led by a tutor or a tutor, whose purpose is the development of the "state of the art" around a theme, to be submitted in writing and be exposed orally to a committee.

a) Formal aspects of presentation:

The works are to be delivered in an electronic format, with a length of approximately 50,000 characters (about 25 pages); see Instructions TFG History Degree, www.uv.es/geohist. They should consist of index, main text (organized in sections), quotes footnotes, conclusions, bibliography and sources, as well as the graphic device (illustrations, maps, graphs, charts, tables, etc.) which is necessary. The wording should be logical and grammatically correct.

b) Evaluation criteria:

Adequacy of work to the indications given by the tutor.

Quality state of affairs of the subject studied. Ability to argue.

Mastery of the terminology of the discipline.

Quality of written statement.

Quality of the oral presentation.
