## TEACHING METHODOLOGY

In theoretical development, the teacher will expose the contents, methodologies and techniques that are necessary to make the student able to acquire the knowledge and abilities that must be achieved. After a magistral exposition, helped with multimedia tools as PowerPoint presentations and online services, the student participation will be fomented through the formulation of problems and questions relative to the theoretical exposition.

Seminars will allow the students to acquire a deeper knowledge in aspects of special interest by a reflexive analysis and discussion of materials provided "*ex profeso*". Thus, the learning process will be active, having the student a key role in the processing and elaboration of the information. Group working will be fomented in the development of the different tasks in the seminar. Practical learning will also be undertaken in small groups. In all cases, the student will first observe the procedures object of study and, after that, he will realize it under the teacher supervision.

The gender perspective, respect for diversity and the sustainable development goals (SDGs) will be incorporated into teaching, whenever possible.

## EVALUATION

The final grade will result from the evaluation of a written test that combines multiple choice questions, short questions and resolution of a practical case (60%) on the one hand and, on the other, from the evaluation of attendance, participation and the resulting reports of practical activities (40%). Each of the three areas of knowledge has a weight in the evaluation proportional to its teaching load, but must be passed separately to obtain approval in the final grade for the subject as a whole.

Attendance at practical activities is mandatory. The student is considered to meet this requirement if he or she has attended a minimum of 80% of these activities and has adequately justified the impossibility of attending the remaining sessions due to the occurrence of a cause of force majeure. It will be essential to comply with this requirement to pass the subject.

Students are reminded of the importance of carrying out evaluation surveys to all teaching staff of the degree subjects.
