TEACHING METHODOLOGY

In the class sessions, active learning dynamics will be carried out in which the acquisition of skills, abilities and skills throughout the entire process.

EVALUATION

The final grade for the course will be the result of a weighted average between the continuous assessment (70% of the final grade) and the final test (30% of the final grade), provided that the student passes both one and the other.

Otherwise and if applicable, the passed part will be saved for the second call.

CONTINUOUS ASSESSMENT (70% of the final grade): From the content point of view, the evaluation percentage will be as follows: Paragraph 1=1 point how is it evaluated?

Half with the exercises/attendance to class or seminars and the other half with the exercises or tests delivered in the virtual classroom

Paragraph 2=3 points how is it evaluated? Half with the exercises/attendance to class or seminars and the other half with the exercises or tests delivered in the virtual classroom Paragraph

3= 2 points how is it evaluated? Half with the exercises/attendance to class or seminars and the other half with the exercises or tests delivered in the virtual classroom Section



4= 1.5 points how is it evaluated? Delivery of written work Section 5= 1.5 points how is it evaluated? Realization of oral presentation Paragraph 6=1 point

how is it evaluated? Half with the completion of a questionnaire in the classroom and the other half with the delivery of a work In short, from the point of view of the evaluation modalities, the percentage of the qualification is obtained as follows:

a) Exercises, questionnaires and tests to be carried out in the Virtual Classroom: 30% of the final grade

This is 50% of sections 1,2 and 3.

b) Delivery of work: 20%

This is 50% of section 6 and all of section 4.

c) Exercises, questionnaires, presentations and activities to be carried out in class: 50%

This is 50% of sections 1,2, 3 and 6. And all of section 5.

In either of the two calls, in the case of a Fail or No Present grade, students have until the date set for the subject exams in the academic calendar to deliver the exercises corresponding to sections a and b to the teacher. .

That is, the Virtual Classroom exercises and the deliveries of works. In relation to the exercises carried out in class (50%) the grades collected in the class sessions for these two calls will be saved.

FINAL TEST (30% of the final grade): Final test that will collect the most important elements of the intended learning results. The teacher will detail the content of this final test before beginning the study of the last thematic unit. To carry out the applied and complementary activities, the subject teacher may use the Service-Learning methodology.

The teaching staff responsible for the subject may determine in the annex to the teaching guide the possibility of changing, with reasons, the modality of the final exam when they are forced to take the test on a date other than the official one in application of the regulations established for the course. case of coincidence of exams in the Regulations for Evaluation and Qualification of Bachelor's and Master's Degrees of the University of Valencia, any other legally established cause (for example, cases of justified force majeure). In these cases, the new type of examination to be carried out must maintain the same level of demand and difficulty as that carried out in general in the rest of the group.

Regardless of the general evaluation system to be established for all students (written or oral exam) established for all the students (written or oral exam), the teacher responsible for the teachers responsible for the course may determine in the annexe to the teaching guide the possibility of changing, with reason, the modality of the final exam modality when it is necessary to take the exam on a date other than the official the exam on a date different from the official date, in application of the rules foreseen for the case of coincidence of exams in the Regulations for the Evaluation and Grading of the Undergraduate and Master's Degrees of the University of Valencia, or any other of the University of Valencia, or any other cause established by regulations (e.g., in the case of established (e.g. justified cases of force majeure). In these cases, the new type of exam to be taken must maintain the same level of demand and difficulty as the one



taken in the rest of the group.

The students who have followed the continuous evaluation and have been evaluated, if they do not take the final exam on the official date of the final exam date (both in 1st and 2nd will obtain the grade of "NOT PRESENTED).
