SUMMARY

Gender and Violence is a compulsory 4th year course, worth 4.5 ECTS credits, which analyzes the influence of gender on the appearance, development and treatment of violence against women due to their gender. To this end, the psychological issues that intervene in the triggering of violence, the criminal issues that describe the corresponding criminal types and their legal consequences, and the procedural issues that justify a jurisdictional treatment and protection of the specific victim are addressed.

TEACHING METHODOLOGY

The subject Gender and Violence is 4.5 ECTS credits. Each week, as a general rule, a session will be dedicated to the explanation of the subject, after preparation by the students with the teaching material available in the virtual classroom, and another session will be dedicated to carrying out applied activities.

As applied activities, viewings of documentaries, comments on sentences, resolution of practical cases... As a complementary activity, an interdisciplinary seminar will be held.

EVALUATION

The evaluation is made up of the resulting average between the evaluation of the theoretical/practical



exam, the continuous evaluation of the applied activities, as well as the note of the complementary activity. Attendance at scheduled activities is compulsory and its assessment will be included in the final assessment.

Theoretical/practical test: test exam (70%) 7 points. It will be necessary to pass the exam to pass the subject.

Continuous evaluation: it will have a weight of 30% in the final grade, which is equivalent to 3 points. Students must take practical tests (problem solving, case studies, papers and presentations, if requested by the teacher), attend and present a report on the complementary activities organized.

Independently of the general assessment system established for all students (written or oral exam), the lecturers in charge of the subject may determine in the appendix to the teaching guide that written or oral exam), the lecturers responsible for the subject may determine in the appendix to the teaching guide the possibility of changing, with reasoned reasons, the mode of the final exam when he/she is forced to the exam on a date other than the official date in application of the rules laid down for the case of coincidence of exams in the Regulations for the Assessment and Grading of Undergraduate and Master's Degrees at the Universitat de València. Master's Degrees of the Universitat de València, or any other cause established by regulations (e.g. justified cases of force majeure). In these cases, the new type of examination to be taken must maintain the same level of demand and difficulty as the one generally given to the rest of the group.

Students who have followed the continuous assessment and have been assessed in the same way, in the event that they do not sit the final exam on the day of the final exam, or of not taking the final exam on the official exam date (both in 1st and 2nd call), will be graded as NOT PRESENT, will obtain the grade of NOT PRESENTED.
