TEACHING METHODOLOGY

There will be 90 hours for the thematic units. The teaching methodology will consist of lectures and both additional and applied activities.

EVALUATION

Grading will attend to the complete and thorough work done by the student throughout the course, his/her participation during the classes, the attendance to the seminars and the marks of the final exam, taking into account the contents, the ability to relate the different administrative legal concepts and the ability to



communicate his/her knowledge properly.

The global exam will take place as established in the official calendar. This exam will be public and may be written or oral.

The global exam will do the 70% of the final grade.

Only if the global final exam is passed with a minimum grade of 5 out of 10 will the weighting be carried out with the continuous evaluation.

Regardless of the general assessment system established for all students (written or oral exam), the lecturers responsible for the subject may determine in the annex to the syllabus the possibility of changing the final exam modality when they are forced to hold the exam on a date other than the official one in application of the rules established for the case of coincidence of exams in the Regulations for Assessment and Grading of the Undergraduate and Master's Degrees of the University of Valencia, or any other regulatory cause established (e.g. justified force majeure). In these cases, the new type of exam to be taken must maintain the same level of demand and difficulty as the one taken in general for the rest of the group.

Students who have followed the continuous assessment and have been assessed, in the event of not taking the final exam on the official exam date (both in 1st and 2nd call), will obtain the grade of NOT PRESENTED.
