SUMMARY

The DFP consists of the autonomous and individual completion by students of a project, under the supervision of an academic tutor, in which the knowledge, competences and skills acquired throughout the



degree programme are demonstrated in an integrated manner.

The DFP can have a practical or professional application orientation or consist in a research project. The DFP can be done in collaboration with institutions, organizations or companies different from the Universitat de València, as long as there is an agreement with them according to the model foreseen in the Regulations of the Final Degree Project and the Final Master's Degree Project of the Universitat de València, and, if necessary, the relevant confidentiality agreements foreseen in the same Regulations are signed; in these cases an external tutor will be appointed who will collaborate with the academic tutor. It may also be linked to the activities of the laboratories, classrooms and clinics of the Faculty of Law.

In the case that the DFP has a practical or professional application orientation, it may be linked or related, among others, to the activities carried out in the external internship course, to the legal clinic, to case studies or to the participation of students in a moot, provided that any of these activities is adapted to the subject matter offered by the Department to which the DFP tutor to which it is assigned belongs and provided that the due confidentiality measures are respected with regard to the data used.

PREVIOUS KNOWLEDGE

RELATIONSHIP TO OTHER SUBJECTS OF THE SAME DEGREE

There are no specified enrollment restrictions with other subjects of the curriculum.

OTHER REQUIREMENTS

To submit the final degree project, it will be necessary to have passed all the subjects from the preceding courses of the study plan and to be enrolled in all the subjects of the last course, the passing of which would allow obtaining a Degree in Law.

COMPETENCES / LEARNING OUTCOMES

Recognise the importance of law as a system for regulating social relations.

Understand the basic functions of the different legal professions.

Understand the legal system as unitary and have an interdisciplinary perspective of legal problems.

DESCRIPTION OF CONTENTS

1. Degree's Final Project of a research nature

If the DFP is a research project, it must contain at least the following elements:

- Delimitation of the object of study (justification and interest of the topic, objectives).
- Methodology and appropriate research techniques.
- Literature review and review of the state of the art in the subject under investigation.
- Data search for the field work.
- Contributions and conclusions reached and proposals, where appropriate.

2. Degree's Final Project with a practical focus

If the DFP has a more practical or professional application orientation, it must contain the following elements:

- Description of the factual assumption.
- Description of the alternatives proposed.
- Evaluation and justification of the alternatives chosen.
- Conclusions reached and proposed solutions.

3. DFP linked to laboratories, classrooms and clinics of the Faculty of Law

The project will be integrated into these laboratories, classrooms and clinics, being developed within them and associated, where appropriate, with specific training.

E.g., in those cases in which a topic linked to the UV LegalTech Lab is offered, the TFG development will include a training period in the LegalTech Lab of the Faculty, with the aim that the student acquires the necessary skills for the development of an app, related to the object of study, which will be part of the project.



4. Information and digital competences. Advanced level (CID-2)

Students who have not previously completed it must take an online training course offered by the Libraries and Documentation Service of the UV called "Advanced level digital and information competences (CID-2)". To do so, each student will receive from his/her TFG tutor a URL and a password to self-register online and be able to take the indicated training. These URL and password will be provided by the Library Service to the TFG tutors at the beginning of the academic year.

The completion of this training will be worth 5% of the total of the final grade of the subject.

CONTENTS

The aim is for the student to consolidate and extend the competences acquired in the basic level, CID-1, applying them to the different fields of knowledge.

To be able to:

- Develop a set of skills and knowledge to effectively search for, manage and evaluate the information they need.
- Know and know how to locate the most appropriate sources of information for their information needs and use all their functionalities.

information needs and use all their functionalities.

- To be able to evaluate and assess the adequacy of the results to their information needs in a search.
- Know how to organise the information used and understand the importance of citations and bibliographic references.
- Know the existence of generators and managers of bibliographic references for the preparation of the bibliography of academic work and DFP.
- Use the computer and collaborative work tools used appropriately and safely.

COMPETENCES TO BE ACHIEVED

- Properly use the advanced utilities of thematic databases: save and reuse searches, alert services, etc.
- Identify gaps in the information retrieved.
- Evaluate and compare results across more than one database.
- Understand what copyright is and what you need to have.

TEACHING METHODOLOGY

The tutor will introduce the student to the techniques of research or, where appropriate, to the preparation of a report or technical opinion on a practical case.

To this end, the tools for searching for information and bibliography on the proposed topic, the treatment and citation of the information obtained and the writing and defence of the work will be put into practice, encouraging the student to take critical and innovative approaches, as far as the chosen topic allows.

The student will provide the tutor with the periodic reports or drafts of work proposed by the tutor and the latter will supervise all the work carried out by the student. To this end, the student must attend the scheduled sessions periodically and consult with the tutor on any doubts that may arise during the preparation of the work.

In the case of field work, a system for recording and organising the information and documentation obtained, such as the portfolio, will be put into operation.

Finally, the teacher will revise the written work carried out, until it meets, in his/her opinion, the necessary conditions of quality to be presented.

EVALUATION

The DFP must be submitted in accordance with the [Instructions for the preparation, presentation and assessment of the DFP at the Faculty of Law](#). If the DFP is accepted for submission, the student will defend it orally before his/her tutor, in the manner and on the dates established in accordance with these Instructions. The lecturer will check the originality of the DFP, using the electronic plagiarism control systems provided by the University of Valencia. The verification of total or partial plagiarism will be sufficient reason to justify a failure in the DFP subject.

In the event that the work has received a grade of excellent and the tutor considers that it is eligible for an honours degree, as it is of special quality and rigour, the assessment will be submitted for examination by the DFP Tribunal, appointed by the DFP Committee.

In order to calculate the DFP grade, the tutor and, if applicable, the examining board must comply with the following percentages:

A) Attendance at tutorials 20%. Within this first part, at least the following aspects must be assessed: The search for materials, the field work carried out and the presentation of reports and drafts.

Within this 20%, the training in information and digital competences described in Thematic Unit 4 must be taken into account, which will account for a quarter of this qualification (5%), unless it has been completed in previous courses.

B) Completion of the work and oral presentation: 80%. In this section, the following criteria, among others, must be taken into consideration:

- The correctness of the structure and clarity in the writing of the exercise.



- Originality in the approach and results.
- Adequate methodology and research techniques (in research work) or analysis techniques (in practical work).
- Sufficiency in the search for data and information.
- The correct use of research tools (in the research work).
- The clarity and coherence of the oral presentation.
