**SUMMARY**

Fourth-year subject of the Degree in Catalan Philology devoted to the study of literature in Catalan from the 16th to the 18th centuries. It is proposed as a continuation and as a complement to the subject Medieval and Early Modern Catalan Literature.

## TEACHING METHODOLOGY

The methodology will combine theoretical and practical activities. Theoretical lessons are devoted to the exposition of the texts. The professors and the students will be able to use the Virtual Classroom and the e-mail with the purpose of communication.

Theoretical:

In the expositive theoretical lessons the professor will explain the historical and cultural context and the rhetorical elements of the texts.

Practical:

The students, guided by the teacher, will read the proposed texts and will comment, with special reference to the content and the style.



At the beginning of the teaching period, the students will be informed of the possible complementary activities that will be organized, and the impact they may have on teaching and assessment.
