SUMMARY

This subject is taught in the third/fourth year, it is optative, and it is included in the general subject: History of the Latin Language.

It encompasses the study of the development of the Latin language itself, also considering its antecedents within the Indo-European context, its predominant relationships with other languages, and its influence on the formation of other languages, particularly the Romance languages. In short, the emphasis will be on the diachronic aspects of the natural and organic Latin language, as well as its various documented or reconstructable varieties.

This subject contributes to the development of elements related to quality education (SDG 4), gender equality (SDG 5), the promotion of just, peaceful and inclusive societies (SDG 16), and the protection of cultural heritage, the promotion of linguistic and cultural diversity and dialogue between cultures (SDG 17), as reflected in Latin language, culture and literature.

RELATIONSHIP TO OTHER SUBJECTS OF THE SAME DEGREE

There are no specified enrollment restrictions with other subjects of the curriculum.

OTHER REQUIREMENTS

A good knowledge of classical Latin grammar and an intermediate or preferably advanced level of understanding of Latin texts are recommended. These requirements must, in principle, have been acquired after successfully completing the previous Latin language courses in the program. Some prior knowledge of general Linguistics, and more specifically of what is known as historical Linguistics, will also be necessary.

DESCRIPTION OF CONTENTS

1. Concept, sources, methodologies.

The discipline of *History of Latin* is defined, the main available documentary sources and their characteristics are described, as well as the methodologies used in their study.

2. Latin, Indo-European language.

Main linguistic characteristics of Latin within the framework of Indo-European languages.

3. The Indo-European languages of Italy.

Enumeration and description of the main characteristics of the other Indo-European languages of ancient Italy, with special attention to Oscan and Umbrian.

4. Etruscan and other anindoeuropean languages of Italy.

Enumeration and description of the main characteristics of the non-Indo-European languages of ancient Italy, with special attention to Etruscan.



5. From Old Latin to Classical and Literary Latin.

Main characteristics of the evolution of Latin from the archaic period to the formation of the so-called *classical* Latin.

6. From Late Latin to Christian Latin.

Defining features of late Latin and its evolution during the Christian era.

7. Medieval Latin.

Main features of organic and patrimonial Latin during the Middle Ages.

8. From Vulgar Latin to Romanesque Creole.

Linguistic factors that determined the formation of the Romance languages.

This content will be reflected in the following learning outcomes:

Students must acquire the main knowledge of the history of the Latin language, understood as the diachronic evolution of the language system and also as the gestation and development of its variants of a synchronic nature, so that they are able to discern in Latin texts the elements of each of the varieties of the Latin language.

TEACHING METHODOLOGY

All topics will be presented, at least in their most important points and content, by the professor in class. It is recommended that students supplement their class notes by consulting and studying relevant works, especially those manuals dedicated to describing specific but basic aspects of the discipline. Additional specific bibliography that is especially useful or relevant to each of the topics or subjects covered will be duly indicated by the professor in class.

EVALUATION

The assessment will consist of two distinct parts:

Assessment Type:

- Individual written exam: 80% of the final grade.
- Continuous assessment of attendance, attitude, and participation in classes or other established activities: 20% of the final grade.

As long as regular class attendance is, under the agreed terms, positively weighted up to 20%, passing the course will require demonstrating, at a minimum, that 30% of the established objectives and identified competencies have been achieved by passing the written test(s) corresponding to the syllabus. Under any other circumstances, the sum of both assessments must always represent at least 50% of the objectives for the course as a whole to be considered passed.

Assessment Criteria:

- Theory: Level of depth, breadth, and precision of knowledge of the facts; level of assimilation.
- Practical: Ability to access data from the discipline's body of knowledge; ability to transmit or ideally develop such data.
