SUMMARY

The subject *Spanish-American Colonial and 19th century literature* offers an explanation of the process of literature in Latin America and an overview of its production from the 15th to the 19th centuries, highlighting its relationship with the society of the continent; in other words, emphasising how literary phenomena are ideological-cultural responses (correspondences and not simply reflections), actively and organically articulated in each phase of social history. In order to achieve this objective, the course includes a subject: *Spanish-American Literature: from the colony to the nations*: it aims to be an approach to a social history of Spanish-American literature through the most significant works, authors and currents of the colonial period and the period of independence.

This subject takes into account various Sustainable Development Goals (SDGs), specifically the following: - In its purpose of "ending all forms of discrimination against all women and girls worldwide" (SDG No. 5), it raises a content program that takes into account the variable of gender, ethnicity and class in all its approaches. - It proposes a reflection on "responsible production and consumption", especially in theme 5, where the reflection on the slaughterhouse space and the human/animal distinction serves to raise the problem of the "ecological footprint and promote changes in the methods of production and consumption of goods and resources" (SDG no. 12).

DESCRIPTION OF CONTENTS

1. Tema 1

How history is written. The conquest of America: victors and vanquished. Law, writing and imperial power.



2. Tema 2

The rhetoric of the conquistadors. Christopher Columbus and the first vision of America. The discourse of success (Hernán Cortés and Bernal Díaz del Castillo). The discourse of failure (Bartolomé de las Casas). The discourse of rebellion (Alvar Núñez Cabeza de Vaca).

3. Tema 3

Frontier stories: La Malinche, Inca Garcilaso de la Vega and El entenado by Juan José Saer.

4. Tema 4

The "Baroque of the Indies" and the process of the emergence of Creole consciousness. Women in the construction and consolidation of viceregal society. Sor Juana Inés de la Cruz: the construction of a female authorship.

5. Tema 5

The construction of a national imaginary. Stories of civilization and barbarism: Esteban Echeverría and Domingo Faustino Sarmiento. Stories of slaughterhouses: Esteban Echeverría and Martín Kohan.

6. Tema 6

Gauche literature. Crossing of texts and crossing of codes: José Hernández, Jorge Luis Borges and Martín Kohan.



7. Tema 7

Women Thinking the Nation: Juana Manuela Gorriti and Gertrudis Gómez de Avellaneda.

These contents will be reflected in the following learning outcomes:

- To have the ability to identify the characteristics of the literary creations of the colonial period in Latin America, as well as the historical and social characteristics of the period.
- To be able to identify the characteristics of a literary work, its ascription to different aesthetic and ideological currents and its transformations.
- To be able to identify the features of literary works, their ideological-cultural raison d'être and their relationship with the Western context.
- To have the ability to use the acquired knowledge to identify research topics and to assess their relevance.
- To have the ability to handle pertinent, specialized and updated bibliographic information.
- To be able to determine and establish the rhetorical architecture of a text.
- To be able to autonomously organize a philological research project.
- To be able to adequately use the key terminology of literary and linguistic analysis, based on contemporary developments in criticism, literary theory and philological tradition.

TEACHING METHODOLOGY

The subject is based on theoretical-practical and tutorial sessions. In the theoretical sessions, the lecturer will present the key concepts of the programme, develop the main contents and raise the more prominent critical polemics and problems about the contents. Problems and discussion of the proposed concepts will be encouraged in order to promote the participation and the implication of the group. In the practical sessions, the compulsory readings included in the programme will be commented, together with the corresponding texts of the critical bibliography. The analysis of this material and the updating of the concepts presented in the theoretical sessions will be the point of departure of discussion in the practical sessions, with the aim of promoting students' critical reflection and active learning.

In individual tutorials, students will be able to solve their doubts about the contents, learn about other sources of useful information for the subject and for further research, get more precise information on how to approach the final exam or extra work and receive guidance for their preparation.

EVALUATION

The grade of the course will be obtained from a final exam, with a valuation of 70% of the final grade, and the delivery of practices, equivalent to 30%. A minimum of 4 points out of 10 in the exam will be a prerequisite to pass the course (on both first and second call).

The exam will consist of the discussion of a topic regarding the contents of the syllabus and the corresponding bibliography.

The practices will consist of analysis and commentary exercises of the contents taught in class. They will be handed in after the subject to which they correspond. The guidelines for their realization will be detailed in each case and will be available through the Virtual and will be available through the Virtual Classroom.

Both in the exam and in the practicals, the professors will value, in addition to the contents provided, the elaboration in the thematic exposition, the conceptual density, the personal contribution of significant quotations of the Works of significant quotations from the works studied, the ability to relate to other subjects related to the contents and the integration of the bibliographic materia (including that provided through the Virtual Classroom). The spelling mistakes and poor writing will be grounds for failure.

Likewise, the use of sources without citing the source and the indiscriminate transcription of any source will be penalized (including failure).

All parts of the evaluation will be recoverable in the second call. In case of not passing the exam in the 1st call and having handed in the practicals, the grade of these will be kept for the 2nd call. It will not be possible, once the exam has been handed in, to present them in the 2nd call to grade them independently or to repeat them to be independently or to repeat them in order to increase the grade. Those who do not take the exam in the 1st call and who have not handed in the practicals will have a special deadline to hand them in at the 2nd call, which will not exceed the date of the exam.
