SUMMARY

The course Literary Practices in the Information Age is part of the optional module Developments in Hispanic Studies, specifically in the subject Applications and Professional Environments of Spanish Literature, aimed at developing the general skills of a graduate in the academic branch of Humanities and, within it, in the Degree in Hispanic Studies: Spanish language and its literatures.

The general objective of the subject is to provide students with the knowledge and methodological tools to deepen their reading training and achieve adequate training or instrumental competence in basic modalities of analytical approach to texts of various types, whether to determine their peculiar uses of language or the specific forms of literary coding in the digital age.

In the context of this subject, the subject Literary Practices in the Information Age is oriented towards knowledge, analysis and creative experimentation with the new forms and languages of the network media, and those specific cultural products of the so-called information age.

This course is particularly aligned with SDG 5: "to achieve gender equality by ending all forms of discrimination, violence and any harmful practices against women and girls".

TEACHING METHODOLOGY



During the theoretical-practical classes (60 classroom hours), the basic problems concerning the place of literature in the digital age will be presented and students will be asked to reflect on them. Literary and critical texts will be dealt with in class. In addition, the teacher will propose collective or individual activities to the students.

EVALUATION

This subject uses the following evaluation procedure:

- a) Course activities: 60%
- b) Final exam: 40%

To pass the course (either on first or second call), it is necessary to pass the final exam and to pass with a total of at least 5 points the summative evaluation of the activities developed (60%) and the final exam (40%).

The student has the right to pass the course in the second call. All parts of the evaluation will be recoverable in the second round.

The general grading system will follow the regulations of the Universitat de València approved by the Consell de Govern on 30 May 2017. ACGUV 108/2017.
