SUMMARY

The subject of General Reverse Translation, being part of the second cycle as compulsory, does not require a specialization on the part of the students, but it does require an advanced level of French. The aim of this course is to reflect on the functioning mechanisms of the source language - Spanish - and the target language - French - before starting to learn the mechanisms of translation. It is a theoretical-practical course in which the difficulty of the exercises increases progressively.

The aim is, through the proposed texts, to address specific grammatical and expressive issues from a contrastive perspective. In addition, students are expected to develop a critical attitude towards translations of texts that have already been published.

There are no specified enrollment restrictions with other subjects of the curriculum.

OTHER REQUIREMENTS



The access to these subjects requires to have passed or be enrolled at least in level B2.

* Students from other universities participating in exchange programs (Erasmus or international mobility programs) signed with the University of Valencia will be exempted from these requirements.

It is required - as a minimum - an advanced grammatical and expressive knowledge of the French language. The working languages will be Spanish and French.

TEACHING METHODOLOGY

We will work with texts that are not stylistically or terminologically marked, such as journalistic texts, advertisements, letters, reviews, instructions, leaflets, brochures, pamphlets, contemporary novels, short stories, etc.

The methodology used in the teaching-learning process will enable students to understand the communicative function of any translation, the importance of the process of constructing the meaning of the source text in order to produce a correct target text that is appropriate to the communication situation and its intention.

The process of creating the target text will be approached as a dynamic act of meaning production that



takes into account both linguistic and semiotic elements (importance of images, photos, typographic characters).

In short, the translating process will be the result of a work of discourse analysis (source text always in Spanish-language A) and an operation of "transfer" of meaning to the target language (French-language B). The translating process will be the subject of collective reflection based on the students' realizations and their different choices.

Theoretical classes:

Theoretical classes will be given at the beginning of the classes and will be introductory to the translation exercise.

Practical classes:

Except for the beginning of the course where theoretical classes will be given, the rest of the classes will be practical. Students will sometimes have to prepare in advance the translations that we will correct and analyze together in class. At other times we will work in groups in order to allow the contrast of points of view and to encourage teamwork. Where possible, mixed groups of native speakers of both A and B languages will be encouraged.

EVALUATION

The evaluation will consist of two different parts:

- 1.- Individual written exam 70%.
- 2.- Translation work submission 30%.

In order to pass the course as a whole, it is necessary to reach at least 50% of each section.

IMPORTANT:

The professor will indicate at the beginning of the course what percentage of the evaluation (and which activities) should be considered as not being recoverable in the second call.
