## SUMMARY

The course Linguistic Studies in French Language 2 is part of the module Linguistic Studies in Language B in the Degree in Modern Languages and their Literatures, with French as the major language. This module is optional and consists of 18 credits, divided into three courses: Linguistic Studies in French 1, 2, and 3.

In the course Linguistic Studies 2, which is taught in French, we focus on the study of morphology and syntax in French. These branches of grammar help us understand how words and sentences are constructed and organized in French, which is essential for both language teaching and translation, as well as for contrastive linguistics and textual analysis.
