SUMMARY

"Estudios de narrativa en lengua alemana" is a course that is part of the major module literature and culture in language B, of the degree in Foreign Language and its Literatures (German). During the course, the aim is to deepen the knowledge of German language literature through the study of representative works of the narrative genre.

DESCRIPTION OF CONTENTS

1. Introduction

The aim is to introduce students to the elements of the narrative text and to reflect on them, fundamentally on the relationships established between them and the aesthetic and emotional effect that certain uses of these elements produce in readers. Aspects of narratology and a classification of the main narrative sub-genres are presented.

2. Die Kurzgeschichte: from post-war literature to the 1990s

The main characteristics of the narrative sub-genre and the historical development from its



emergence in German literature to the present day are presented.

3. Die Novelle

The main characteristics of the narrative sub-genre and its historical development from its emergence in German literature to the present day are presented.

These contents will take the form of an in-depth knowledge of narrative in German; an increase in the ability to read, interpret and analyse works of literature in German; the ability to comment on a literary text in German, applying methods of analysis and operational concepts of literary criticism; and an increase in the ability to develop in writing and presenting in German a critical and synthetic reflection on aspects of the literature studied, applying operational concepts of literary criticism and literary studies; in the increase of the ability to develop in writing and to present in German a critical and synthetic reflection on aspects of the literature studied, applying operative concepts of literary criticism and literary studies; in the reinforcement of communicative competences in German; in the knowledge and understanding, within the scope of the degree itself, of the inequalities based on sex and gender in society; in the integration of the different needs and preferences based on sex and gender in the design of solutions and problem solving.

TEACHING METHODOLOGY



In the **theoretical classes** we will use a hybrid model combining the expository and the communicative didactic model. The expository model uses explanatory methods that focus on showing the interdependence between concepts and facts, and include the repeated use of different skills. The focus is on conceptual content and basic skills are emphasised. Verbal interaction between teacher and student is fundamental. In the **communicative didactic model**, the teacher guides the students through methods of dialogue, discussion and problem solving in a climate of peer interaction. The student learns empirically in relation and interdependence with the teacher and the rest of the classmates, sharing perceptions and ideas about reality and collectively reconstructing knowledge. Learning is centred on discovery, understanding the logic of the subject matter and the social, cultural and ethical problems that derive from it.

In the **practical classes**, this methodology will be complemented with the transactive didactic model, that is to say, use will be made of the didactic resources and technological means available (Virtual Classroom, Internet...) for self-learning. This model focuses on the students' interests, guiding their academic and personal growth. The student explores and discovers the subject guided by their own interest through interaction with the material and human environment, working individually or in small groups tutored by the teacher and often in a self-instructive way. In this way, learning to learn skills are promoted and interdisciplinarity is fostered.

This subject takes particular account of SDG 5 and SDG 16, as the selection of the works in the syllabus has been made according to criteria based on gender equality and the reinforcement of democratic values and social justice.

This subject is part of the Consolidated Educational Innovation Project INNOVA-TEA (UV-SFPIE_PIEC-2735478) and follows the activities approved by the SFPIE of the UV.

EVALUATION

The assessment will consist of 3 differentiated parts:

In order to pass the course as a whole, it is necessary to pass section A with a minimum of 5 out of 10.

A. Written tests:

Portfolio with comments on the texts analysed in class and creative writing assignments. Assignments can be made up at the second official exam session.

c. Attendance and participation in class

This part cannot be made up at the second official exam period.

The grades obtained in different sections in the first call will be maintained.
