SUMMARY

English Language II is a compulsory first-year (second semester) subject that is part of the module *English Language and Linguistics* and the sub-module *English Language* in the English Studies degree programme



of the Universitat de València (approved in 2010). It is also part of the Translation and Interlinguistic Mediation programme and of the English Studies *minor* in the Modern Languages and Literatures, Catalan Language and Literature, Hispanic Studies, and Classics degree programmes. In the English Studies degree, this subject is related to the series *English Language I-VIII* in the aforementioned module and also to other subjects in the *English Linguistics* sub-module such as *English Phonology*, *History of the English Language*, *English Morphology and Lexis*, *English Syntax* and *Second Language Acquisition*.

The aim of the course is to develop communicative skills in English (listening comprehension and oral expression, communicative interaction and mediation) up to Level B2 in multiple contexts. At the same time, the course aims to promote autonomous learning, self-assessment, and remedial work with the lecturer.

Summary of Linguistic Content in English Language II

The texts and activities we will see are designed to introduce students to some of the social, geographic, gender and age variations in English. Although we will be looking at each in turn, it should be obvious that all four types of variation overlap. We will also look at some of the important concepts in the fieldsuch as accent and dialect, standardisation, language planning, prescriptive and descriptive approaches to language.

1. Unit 1. Dream of the stars

Grammar: Modal verbs to express certainty and possibility

Vocabulary: 'achieve', 'carry out' and 'devote'; 'stay', 'spend' and 'pass'; 'make', 'cause' and 'have'

Linguistics: Varieties in Britain



2. Unit 2. The power of the mind

Grammar: 'as' and 'like': modals expressing ability

Vocabulary: 'arrive', 'get', and 'reach'; phrasal verbs: 'come up with', 'pull in'

Linguistics: Varieties in the USA.

3. Unit 3. Spend, spend, spend

Grammar: 'at', 'in' and 'on' in phrases expressing location. Reported speech

Vocabulary: Verb collocations with 'ambition', 'career', 'experience' and 'job'; 'play', 'performance' and 'acting'; 'audience', '(the) public' and 'spectators'; 'scene' and 'stage'

Linguistics: Introduction to language, accent and dialect

4. Unit 4. Medical matters

Grammar: Relative pronouns and relative clauses

Vocabulary: Idiomatic expressions: 'taken aback'. Health vocabulary: 'illness', 'infection' etc.

Linguistics: Varieties in the rest of the world.

5. Unit 5. Animal kingdom

Grammar: Third conditional and mixed conditionals; 'wish', 'if only' and 'hope'

Vocabulary: 'avoid', 'prevent' and 'protect'; 'check', 'control', 'keep an eye on' and 'supervise'.
Negative prefixes

Linguistics: Standardisation.

6. Unit 6. House space

Grammar: Causative 'have' and 'get'. Expressing obligation and permission

Vocabulary: 'space', 'place', 'room', 'area', 'location' and 'square'

Linguistics: Prescriptive and descriptive approaches to language, prestige.

7. Unit 7. Fiesta!

Grammar: The passive

Vocabulary: Festivals: 'celebrate', 'commemorate', etc. Suffixes to form personal nouns

Linguistics: Gender and age factors.

For English Studies students:

Upon successful completion of this course, students should:

- Demonstrate communicative and social competence in English (listening comprehension and oral expression) at B2 level of the Common European Framework of Reference for Languages (CEFR).
- Use English to explain linguistic phenomena, i.e., acquire metalinguistic skills.
- Recognise different grammatical categories and their corresponding functions and relate them to situational factors in discourse.
- Use tools, programs, and software specifically designed for the study of English language and literature, including email, blogs, and the virtual classroom.
- Identify and understand some of the main terms in variationist linguistics, such as the concept of standardisation, prescriptive and descriptive approaches to language, prestige, etc.
- Compare Received Pronunciation (RP) with other English accents and be aware of vocabulary and grammar differences between British English and other varieties.

For Translation and Interlinguistic Mediation students:

TEACHING METHODOLOGY



For students to reach the required level of English (see competence 14) and develop other competences which are also specified in this syllabus the following methodological approaches will be implemented:

- the teacher will formally present key concepts and also counsel, facilitate, organize, monitor, liaise, correct and assess students.
- the teacher will promote student-centred activities through some or all of the following: individual work, pair work, group work, problem solving, project work, and task-based learning.

Autonomous and/or group learning inside and outside the classroom, including computer-based activities will be encouraged.

Your teacher will give you information on requisites relating to attendance at the beginning of the course.

EVALUATION

Assessment breakdown for first and second call.

A) Individual final examination that includes a listening test and a use of English test.	50%
B) Final oral test	30%
C) Activities carried out during the course	20%

To pass the subject students need to get at least 50% as an average of parts A, B and C. Students must also get 50% in each section of part A and 50% in part B. The mark for the 20% of part C will be carried over



to the second call. These activities (part C) can only be done during the course and cannot be handed in for the second call. The mark for these activities (part C) is only counted if the student passes parts A and B.

If a student fails one part of the examination, he/she would need to take all the parts again.

Assessment Criteria

Students will need to show that they have grasped the concepts introduced by their lecturer(s). They will also have to demonstrate that they have learnt the lexical, grammatical and functional items to be used in the multiple contexts seen in class.

Students will also need to show that they have attained a B2 competence level in and that they have acquired a satisfactory level in the other specific competences.
