SUMMARY

The Degree-Final Dissertation (DFD) is an independent and individual assignment, equivalent to twelve credits, that each student must complete in the language of the Major they have studied, under the supervision of a tutor, during the fourth year of the Degree in Modern Languages and their Literatures. This project should allow the student to demonstrate in an integrated manner the educational content received and the skills acquired in relation to the degree. The Degree-Final Dissertation (DFD) allows for different formats, in accordance with the students' various interests and the methodological requirements of the different fields of German, French, and Italian philology.

DESCRIPTION OF CONTENTS



The student may choose one of the following types of work:

1. A critical synthesis of the knowledge acquired and the competencies developed during their studies, accompanied by a reflective analysis of their application in one or more professional fields chosen by the student. This type of project may be linked to external internships.
2. An introductory research project in the field of the German, French, or Italian language and their respective literatures.

These contents will be reflected in the following learning outcomes:

1. Development of communicative competencies in language B.
2. Development of the ability to design, adjust, and carry out a project.
3. Reinforcement of autonomous learning.
4. Deepening of the thematic area chosen for the project.

TEACHING METHODOLOGY

1. The Degree-Final Dissertation (DFD) must always be carried out under the supervision of an academic tutor. The tutor may be any full-time faculty member holding a doctoral degree and belonging to the academic field to which the DFD is assigned in the Viability Plan. The tutor is responsible for explaining the characteristics of the DFD to the students, guiding them in its



development, and ensuring the fulfillment of the established objectives.

2. The DFD Committee may authorize a project to be supervised by more than one tutor. In such cases, at least one of the tutors must meet the criteria outlined in the previous paragraph and will be the one to propose the co-supervision to the Committee.
3. The supervision of the project will be reflected in the tutor's POD (Teaching Activity Plan) and will be recognized in accordance with the university's regulations. If the supervision is shared by more than one professor from the University of Valencia, the recognition will be distributed among all of them.
4. If the DFD is carried out in an institution, organization, or company other than the University of Valencia, that entity must appoint a tutor who, acting as an external tutor, will collaborate with the academic tutor in defining and developing the content of the DFD.
5. The student may submit their DFD only if they have received approval from their tutor.

EVALUATION

The DFD will be evaluated by a commission of three competent members in the language of the maior in which the work is written.

The knowledge and competences of the type of work and of the subject treated, its defense and the grammatical knowledge and communicative competences in language B will be evaluated.

In order to issue the corresponding quantitative and qualitative qualification, the court will take into account the following aspects:

- Objectives, methods and results obtained.
- Structure and formal presentation of the work.
- Use of and references to the sources consulted.
- Oral defense.
- Grammar and stylistic correction of the use of the language of the maior.

The inclusion of material belonging to third parties not correctly identified as such that could be considered plagiarism by the court will mean the dismissal of the DFD and the qualification of suspense.

The tutor may reject the work submitted 15 days before the end of the deadline for submission of the official call.
