**DESCRIPTION OF CONTENTS****1. Content of the Degree's final project**

The TFG must consist of three parts: the project, a personal evaluation of the degree by the student, and a Curriculum Vitae (CV).

Project

The project must be related to issues specific to business management and administration, in any of its functional areas and/or organizational levels, or to the socioeconomic environment in which companies operate, by analyzing real contexts, or by addressing a relevant theoretical question. In both cases, the work must be theoretically grounded and include practical applications with either practical or academic implications.

In any case, the project will consist of an introductory section, the main body of the work, and a final section presenting conclusions, bibliography, and appendices or annexes (if applicable). Each section must have an appropriate title and may include properly subtitled subdivisions.

A more detailed presentation regarding the cover page to be used, work structure, statement of responsibility and audit, declaration on the use of artificial intelligence, bibliographic citation rules, etc., can be found in the **TFG Guide**, available at <http://go.uv.es/S6Yzla>.

Personal evaluation of the degree

The student must provide an evaluation of the Business Administration Degree: what it has represented for him/her in terms of training, the aspects to be improved, and the positive aspects. This evaluation must be written in a constructive spirit, and inappropriate or derogatory language will not be accepted. The maximum length will be 400 words.

Curriculum Vitae

A brief CV specifying the average grade of passed credits, certified language proficiency levels, academic stays abroad, and professional experience.

- Quality, style, and methodology (20%).
