SUMMARY

Contemporary World History is a one-semester basic training course taught in the first year of the Bachelor's Degree in Political Science and Public Administration. The course is structured around the study of major global historical processes in the contemporary era. It complements other compulsory subjects, such as *History of Institutions in Contemporary Spain*, and other basic training courses like *History of Political Thought I* and *History of Political Thought II*.

The course is designed to provide students with foundational historical knowledge that will support their understanding of more specialized subjects in subsequent years.

The general objective of *Contemporary World History* is to offer a broad understanding of how modern societies and political systems were shaped, through the study of key historical events, challenges, and processes that defined the 19th and 20th centuries and contributed to the configuration of the contemporary world.

Additionally, the course aims to move beyond a traditional view of history as a mere succession of events,



figures, and political or military developments, by adopting broader perspectives that incorporate sociopolitical and cultural dimensions, which are essential for the academic training of political science students.

TEACHING METHODOLOGY

1. On-site sessions (i.e., in the classroom allocated for the course or student group) will be distributed as follows:

1.1. Lectures: participatory master classes. The lecturer will present and explain the key elements that should guide students in their study and understanding of each topic. Students are expected to take an active role in their learning process by completing the assigned readings; textbooks, monographs, or other materials; before or during class sessions, depending on the schedule.



1.2. Practical classes: debates, discussions, and in-class activities. These sessions will delve deeper into the most relevant or significant aspects of each topic using a range of materials (historical and historiographical texts, films, documentaries, etc.). Participation and preparation for practical sessions are mandatory and will be subject to assessment. These sessions will also serve to familiarize students with the concepts, materials, and methods specific to the discipline of history, and to the analysis of political history in particular.

2. Non-scheduled tutorial sessions:

2.1 Students may attend the regular office hours offered by the instructor to discuss any aspect of the course or their individual work. These tutorial sessions should be considered an extension of classroom instruction and not as occasional or exceptional activities.

2.2 Tutorial consultations may also be conducted by email, depending on the instructor's availability and guidelines.

3. Scheduled tutorial sessions: Where appropriate, the instructor may arrange individual or group meetings with students to:

- Monitor their academic progress and learning process
- Supervise and assess reading assignments and other coursework

4. In addition, specific course-related, interdisciplinary, or cross-curricular activities may be scheduled in coordination with other groups or courses. These will be designed to explore in greater depth topics or issues of special interest. Appropriate academic and administrative planning will be ensured, and such activities will be duly assessed within the learning process.

EVALUATION

The assessment of the course will include the following components:



1. Written and/or oral exam on theoretical content. This component will account for 60% of the final grade.
2. Evaluation of reading assignments and/or individual or group projects, which may include written papers or other forms of coursework. This component will account for 40% of the final grade.
Note: this portion is non-recoverable.

To pass the course, students must obtain a minimum of 5 out of 10 on the written/oral exam. Otherwise, the remaining components will not be counted.

Second examination session:

- Students must retake the written and/or oral exam and achieve a minimum of 5 out of 10. If this minimum is not met, the coursework grades will not be included in the final grade.
- Coursework marks (reading assessments, group or individual assignments) from the first session will be retained and applied in the second session.
