SUMMARY

The compulsory course "External Internships" is aimed at Law and Economics students who are at an advanced stage of their double degree. Students enrolled in this course will be able to complete a period of internship work related to the academic content of the degrees they are pursuing at UV, in law firms, companies, and/or public and private institutions. These internships will be supervised and mentored by a tutor from the Faculty of Economics or the Faculty of Law, preferably from the area of specialization of the position offered.

The objective of the Company Internships offered to students of the double degree in Law and Economics is to achieve, through a period of integration in a company, that they acquire the technical skills (knowledge), learning skills (know-how), interpersonal skills (know-how), and thinking skills (know-how), which will enable them to integrate into the world of work with greater guarantees of success.

External internships are training activities undertaken by students in companies, institutions, or organizations. The objective of these internships is to complement the student's training through a practical period, with the following objectives, among others:



- Gain insight into professional life.
- Introduce students to the problems of the company, institution, or organization.
- Utilize the theoretical and practical knowledge acquired during the degree program in companies and public and private institutions.
- Complete projects that test students' critical and reflective skills and put their analytical and synthesizing skills into practice in the areas studied.

The Faculty of Law's Internship Committee is responsible for regulating internships in the Law & Economics degree program, Javier Guardiola García, Vice Dean of Criminology Studies and Academic Coordinator, is responsible for the Faculty of Law. At the Faculty of Economics, Paz Rico Belda, the head of the Internship Committee, acts as the Internship Coordinator.

TEACHING METHODOLOGY

- Placement in companies, entities, organizations and/or tourism institutions, developing varied tasks depending on the profile of the position held, and complemented where appropriate with theoretical-practical training being put into practice.
- Attendance at supervisory meetings with the company tutor.
- Attendance at supervisory meetings with the academic tutor.

EVALUATION

The student will submit a report on the activities completed to the academic tutor, following the instructions found in the internship guide for the Law Degree or the Business Administration Degree, depending on whether the internship is supervised by a professor from the Faculty of Law or the Faculty of Economics.

The tutor from the company or institution will receive the Final Evaluation Report electronically at the end of the internship, which will be completed and sent electronically to the academic tutor.

The Academic Tutor will evaluate the internship upon completion. The student will be assessed for achieving the general objectives of the curricular internship, as well as the specific objectives of the assigned internship, according to the program of activities agreed upon in their internship agreement.

The evaluation must be reflected in the transcript with a grade at the end of the semester.

If the academic tutor is from the Faculty of Law, he/she will not be able to assign the grade of honors directly, but will have to propose it to the Center's Internship Committee whenever appropriate.
