SUMMARY

The Master's Thesis (TFM) consists of the completion by the student of an article or a theoretical work, in which he/she applies and develops the knowledge and skills acquired in the courses followed and, as far as possible, includes innovative aspects of the research topic.

It must be carried out in the final phase of the study plan, it is compulsory and has a teaching load of 8 ECTS. It must be carried out individually and under the supervision of the assigned director.

The student who has submitted the TFM will be considered the author of the work and solely responsible for any third party claims that may arise with respect to copyright.

The TFM will conclude with its defense, in which the student must make a presentation of the work in public and in Spanish before a commission composed of three members who will evaluate the research.

DESCRIPTION OF CONTENTS

1. Master's thesis

The TFM consists of the completion of an unpublished and original work, prepared autonomously and individually by the student, under the guidance of a director.

This work can be carried out in two different modalities: article and research work.

2. Article

In this modality the works will deal with concrete and specific topics and will have a minimum length of 30 pages.

These are the necessary sections in a TFM LEGAL ARTICLE MODALITY:

- Cover page
- Abstract
- Key words
- Summary
- Legal foundations
- Conclusions
- Bibliography

3. Research work

In this modality, the works will deal with general topics and will have a minimum length of 80 pages.

These are the necessary sections in a TFM RESEARCH WORK MODALITY:

- Front page
- Abbreviations
- Index
- Introduction
- Legal foundations
- Conclusions
- Bibliography

TEACHING METHODOLOGY

Each student will be assigned, individually, a TFM director whose function will be to guide him/her during the completion of the work, supervise it and ensure compliance with the objectives set (index, approach, methodology, development of the work, search for sources, etc.) and, finally, to authorize or not that the work may be presented to the evaluation committee for grading in the act of defense.

The TFM, regardless of the chosen modality, must respect the following formal rules:

1. Doctrinal and jurisprudential notes.

Contributions will be footnoted to the extent deemed necessary.

1.1. Doctrinal citations will be made, in any case, in footnotes. APA model will not be accepted.

The author should be cited (in capital letters, by surname and first initial), the work (in italics if it is a book, in quotation marks "-" if it is an article, book chapter or commentary), the journal (if applicable, by its abbreviation) or book (in italics, both the journal and the title of the book), both the journal and the title of the book where it was published, the edition (if it is a book), the date (without the thousands point), the place of publication (if it is a book) and the page or pages on which the opinion is expressed (with the abbreviation p. or pp. and, if applicable, without the thousands point). Example: DÍEZ-PICAZO Y PONCE DE LEÓN, L., *Fundamentos del Derecho Civil Patrimonial*, vol. II, *Las relaciones obligatorias*, 5th ed., Madrid, 1996, p. 659; PANTALEÓN PRIETO, A. F., "El sistema de responsabilidad contractual (Materiales para un debate)", *ADC*, 1991, pp. 1022 and 1048.

Subsequent citations of the same work may be abbreviated, but always making sure that the work is easily identifiable. For this purpose, it is recommended to include the author (in capital letters) and the initial words of the title (in italics if it is a book and in quotation marks if it is a doctrinal article), followed by the abbreviation "cit.", indicating finally, and in any case, the page or pages on which the opinion cited is expressed. Example: DÍEZ-PICAZO Y PONCE DE LEÓN, L., *Fundamentos del Derecho Civil Patrimonial*, vol. II, cit. p. 659; PANTALEÓN PRIETO, A. F., "El sistema de responsabilidad contractual...", cit. pp. 1022 and 1048.

1.2. Case law citations must include the day, month and year and the reference to a database (westlaw, Tirant or cendoj). Example: STS 3 June 2014 (TOL 4.395.123), STS 12 May 1981 (RJ 1981, 2048).

Font and paragraph formats

2.1. The text shall be formatted in New Times Roman font size 12. Notes in the same font, size 10.

2.2. Paragraphs should be spaced 1.5 line spacing.
