TEACHING METHODOLOGY

Theoretical classes with lectures by the teacher and student participation in discussion and reflection on problems, either orally or in writing.

Seminars and practical activities in the classroom or laboratory supervised by the teacher, including case studies, use of computer applications, presentation of work in front of the group, discussion and conclusion.

Teamwork activities.

Individual and group tutoring.

EVALUATION

The student's assessment will result in a grade ranging from 0 to 10 points.

These grades represent: 5 points or above, pass; 7 points or above, B; 9 points or above, A; 10 points, A proposed for honours.

This course consists of several modules taught by different teachers who are experts in their respective subjects.

The final grade for the course will be the average of the grades obtained in the various modules that comprise it. In each module, the teacher will propose a form of assessment to the student consisting of a theoretical-practical exam in accordance with the subject matter (30% of the grade), assignments and/or practical case studies and other types of practical activities carried out during class (30% of the grade) and an assessment of the student's participation in the scheduled activities (40%).

Each teacher will grade the level achieved by the student on a scale of 0 to 10.

The final mark for the course will be the average of the marks obtained in the various modules. To pass the course in the first sitting, it will be necessary to pass each of the modules that make it up separately. If the student has failed to submit any assessment work, it will be considered not submitted. In the second sitting, the average of the marks obtained in each module and the number of modules will be calculated.

The master's degree is classroom-based and to pass the course, students must attend at least 80% of the classes. Non-attendance must be due to well-documented reasons of force majeure (sudden illness, death of a relative up to the third degree, court summons, official exam, accompanying a first-degree relative for medical reasons).

The content and activities carried out in the face-to-face classes can be made up through specific assignments, except for activities that require instruments, techniques, materials or content that cannot be repeated or simulated (e.g. videos, audio recordings and other materials that form part of real clinical cases). Each teacher responsible for a module will inform students of which content can be made up and which cannot, as well as how and when it will be made up.

The awarding of honours is subject to the completion of an extraordinary oral exam in the event that two students have the same grade and only one MH can be awarded. This test will not reduce the grade in any case.
