**TEACHING METHODOLOGY**

MD7 - Those inherent to a management task, including, where appropriate, consulting background information, attending public sessions of judicial, administrative or mediation and negotiation bodies in which problems to be dealt with by the student in his/her work are addressed.

In the research itinerary, the topic will be specified by agreement between the student and the director assigned by the Academic Committee, having to respond to a specific topic of specialization that will be treated with the methodology, criteria and sources of a research paper.

In the professional pathway, the topic will be specified by agreement between the student and the director assigned by the Academic Committee, within the framework of one or more of the subjects and modules that make up the Master's. Its structure and approach will be that of a professional legal opinion on the case and the facts that the student himself raises and that he must describe in the first pages of his work, so as long as they allow several options or legal solutions of which the student will have to justify what he proposes or advises.

In both modes, the work will be based on Spanish law or international law, without prejudice to the references or analyzes of comparative law that are deemed appropriate, but without this meaning that the basic normative framework of the work is a order of another country.

**EVALUATION**

The evaluation of the master's final project will be carried out in accordance with the Regulations for the development of the Master's Final Project approved by the University Governing Council and the instructions issued by the Master's Academic Commission.



Once it has been verified that the student has passed all the modules of the Master and has been submitting the required quarterly reports, the Court will assess the following aspects:

- Complexity and relevance of the problems addressed
- Legal qualification, where applicable, of the facts described
- Management and understanding of legal categories and institutions
- Correct use of legal sources and documentation
- Systematics and structure of the work
- Relevance and foundation of the conclusions reached
- Clarity and conciseness of the presentation
- Originality and novelty of the treatment or conclusions in the research itinerary.

If the Panel of professors considers it appropriate, it may establish other mechanisms additional to the deposit report so that the director of the work participates with the Panel, with voice but without vote, in the final evaluation. The Panel's grade, between 0 and 10 points, will be the result of the previous criteria, being incorporated into the TFM report.
