The course Theoretical and Axiological Foundations of Psychosocial Intervention is part of the first module of advanced basic training Theoretical and Methodological Foundations of Psychological Intervention in Social Settings, which covers the subjects of methodologies and designs and evaluation of psychosocial intervention programs. This first module of advanced basic training aims to provide a body of conceptual, procedural, technical, and attitudinal knowledge that will enable psychology professionals to carry out interventions in social settings.

The subject Theoretical and Axiological Foundations of Psychosocial Intervention is taught in the first semester of the first year of the master's degree. This subject offers specialized knowledge related to the main foundations and theoretical models of psychosocial intervention, as well as the ethical and moral values that underpin the professional practice of social and community intervention.

TEACHING METHODOLOGY

The working methodology is divided into four different sections:

a) Group learning with the teacher.

This methodology will focus on theoretical classes, which provide an overview of the subject matter and highlight key concepts. It will also focus on practical sessions carried out in small groups. This strategy is useful for achieving three objectives: the development of oral and written communication skills, the development of intellectual and professional skills, and the ability to work in a group.

b) Personalised guidance for students

This involves guiding students in their learning activities, helping them to search for, locate, analyse, prepare and present the information they have worked on.

c) Tutorials

These will be individual and in small groups with the aim of solving problems, directing work, etc. The Virtual Classroom forum will be used to facilitate queries and clarifications that may be of interest to the working groups.

d) Preparation of assignments

Students must complete individual and group assignments.

EVALUATION

The evaluation of the course will be based on two complementary criteria: evaluation of results and evaluation of the learning process.

1. The evaluation of the results will be carried out at the end of the module by means of a final

test. This final test will assess the assimilation that the student has made of the contents of the subject. This test will constitute 40% of the grade (4 points).

2. The evaluation of the process (continuous evaluation) in each subject will be carried out by means of the activities and works (individual and/or group) carried out in the classroom and/or outside of it. This section will constitute 60% of the grade (6 points).

The activities and works may consist of:

- Readings of recommended texts and their subsequent critical analysis.
- Practices carried out in the classroom and elaboration of memories.
- Exhibitions and debates in the classroom.
- Seminars, conferences, visits, film forum.
- Resolution of assumptions and practical cases.
- Application work on the contents of the subjects.
- Works of empirical investigation about the contents of the subject.

In the case of not passing the continuous evaluation of one (s) subject (s) of the module, the student must recover that part of the subject, not having approved the module until he/she has not passed that part. Final grade: It will be an essential requirement to pass this module to have 80% of class attendance and to have obtained a minimum grade of 2 out of 4 in the final test (evaluation of the results) and a 3 out of 6 in the activities and work of each one of the subjects (evaluation of the process).
