**SUMMARY**

The subject is part of the third module "Psychological promotion of psychological well-being, social and community". This subject consists of 2 credits, and is taught in the first semester of the first year of the Master's degree.

This subject aims to reflect the regulatory context that nourishes the Valencian Public System of Social Services, providing it with a functional, territorial and competence structure. It also aims to point out those concepts that are essential in these contexts. At the same time, it seeks to offer a description and analysis of the role of the psychologist in the context of Social Services, both in primary care (basic and specific) and secondary care.

The aim is to convey to students the complexity of these environments and the competences and skills that it is important to acquire in order to perform adequately in these multi- and inter-professional contexts, highlighting the strengths and difficulties that psychologists will have to deal with. All this from a fundamentally practical and applied methodology.

## TEACHING METHODOLOGY

The methodology will be fundamentally participative, integrating the development of the competences of the subject. The methodological techniques to be used will be:

- Lectures and presentations of theoretical and practical content.
- Practical activities: dynamics, presentation of real cases, debates, analysis of regulatory texts, sample of materials and documents of daily use in the field of social services...
- Autonomous preparation of group work.
- Resolution of doubts about the theoretical-practical contents.

## EVALUATION

The evaluation of the subject out of 10 points (or grade) will be carried out by means of:

1) Assessment of the process: the knowledge, skills and competences acquired will be assessed through student participation during the classes, as well as in the group performance of the practical case study proposed by the lecturer. This will have a total value of the subject of 6 points.

2) Performance assessment: at the end of the module, the student will take a performance test on the level of competences or learning acquired in the module. This will be a multiple-choice test with 4 alternatives and will have a total value of 4 points for the subject.

In both cases it will be necessary to reach half of the score to consider the subject passed.

The first sitting will be recoverable, being able to take an exam in the second sitting, or the completion of an individual work related to the context of Social Services.

With regard to the awarding of an honours degree, this will be assigned to the student who obtains the highest total mark (out of 10), taking into account the decimals. One honours degree will be awarded for every 30 students.
