After completing the academic part and accumulating theoretical knowledge, the student has to develop the professional practice, where he/she will have the opportunity to apply the acquired knowledge to the real world. The acquisition of this knowledge will be assessed in the Master's Final Project, for which students will be provided with a practical guide of the content of the project. This content must be discussed with the tutor, who will be responsible for clarifying or expanding on these headings.

The Master's Thesis is the development of an ORIGINAL and RIGOROUS study on a business problem of an international nature using an appropriate theoretical analysis and an adequate research methodology to achieve the objectives set. It is always desirable that it contributes, that it is useful, for a company/organisation or that it represents an advance in knowledge.

STRUCTURE OF THE FINAL MASTER'S THESIS

In general, the thesis/memorial should contain at least the following headings:

1. Description of the company/institution in which the internship is carried out.
2. Description of the activities carried out by the student (with emphasis on those that involve greater interest or a greater contribution by the student in terms of added value).
3. A central section linking the contents of the academic part of the Master's Degree with the student's activities in the company/institution or with the general activity of the company/institution itself. To this end, the student will adopt one (or more) of the following approaches:
 - a. Geographical: analysing one or more of the countries/regions/geographical areas that constitute the company's market or the institution's sphere of activity, using the perspectives offered by the different subjects of the Master's degree.
 - b. Sectoral: analysing one or more of the sectors or sub-sectors in which the company or institution operates, using the perspectives offered from the different subjects of the Master's degree.
 - c. Functional: analysing in detail the activity of one or more of the departments/functional units/directorates... of the company or institution, using the perspectives offered from the different subjects of the Master's degree.

NOTE: it is not a question of identifying which contents of each specific subject you have used in practice or in the analysis of the sector or market, but of using contents seen during the course in the different subjects to carry out this section, citing those sources when required, for example at the foot of the page.

4. Personal contribution based on knowledge acquired regarding the resolution of a company situation, a customer proposal, the design of a strategy or some new aspect for the company
5. Personal and professional assessment of the internship by the student.

In relation to students who opt for an academic profile work, the defence of the work/memorial will consist of the presentation of a document that must include the contents and structure in accordance with a scientific

FORMAL ASPECTS OF THE MASTER'S DISSERTATION

- The dissertation may be written in Spanish or English. The presentation can also be in either language, and the written presentation in one of them does not condition which language is used in the oral defence.
- In the Master's Degree we do not define formal parameters relating to font type, line spacing, subdivisions and the way in which the different sections are numbered, etc., which are left to the discretion of the student.
- However, it is expected that every dissertation should have some formal elements that we consider necessary:
 - o The cover page must contain the Title of the TFM, the name of the student and the name of the tutor. The name of the Master, the Institute of International Economics and the University of Valencia must also appear. Whether it is accompanied by other elements (such as photographs, the name or logo of the



internship company or the company where the student is employed, etc.) or the way of presenting the aforementioned elements is left to the student's choice.

o The TFM must be structured in the following order:

- ¿ Title page
 - ¿ Acknowledgements (if applicable)
 - ¿ Abstract / Resumen: in English and in Spanish
 - ¿ General index
 - ¿ Index of Figures: subdivided into Tables / Graphs / Images
 - ¿ Index of acronyms / abbreviations
 - ¿ Main text, with the sections indicated on the previous page of this document or, failing that, those established with the corresponding tutor.
 - ¿ Bibliography, cited in accordance with generally accepted academic criteria. It is very important that it is also cited appropriately throughout the work. See as a reference, if necessary, the document on `How to cite correctly¿ that appears in Topic 1 of the subject International Economic Situation.
- o The graphic support to the written text must always be numbered, with a title, and with the source at the foot of the support.

ASSESSMENT CRITERIA

The assessment of the Master's thesis will be based on the following general criteria:

- Clear establishment of the question to be analysed and the objectives of the project.
- Adequate and exhaustive analysis of the relevant literature for the analysis of the question under studyUse of a sufficient variety of sources of information and their triangulation.
- Appropriate choice and use of analytical tools and/or research methods.

Rigour in the processing and analysis of the information and data collected for the research.- Quality of the author's perspective and point of view, conclusions and propositions derived from the work carried out in accordance with the stated objectives.

- Structural integrity of the paper, correct use of references and bibliography, precise use of terminology, etc. It should indicate, if applicable, how AI has been used in its preparation.

Important note: Master's theses that the Assessment Committee determines to be plagiarism will be graded with a Fail (0.0 points).
