**SUMMARY**

The subject 'Family Change and Wellness' (6 ECTS) module is included in the contexts of family intervention to be completed with the subject 'Contexts family intervention'. It is the student's first contact with the Master of Social Welfare: Intervention group, social and family.

The transformation that families have experienced in recent decades has shown a host of new needs to cover. For the Social Work is essential to know the changes in family relationships and how they affect to the people's welfare. Consequently, this course aims to provide a panoramic view of the transformation of the family, especially about the greater diversity of family forms to which we are witnessing in recent years; focusing on the implications these changes have on their ability to supply welfare.

The course is divided into two large blocks of content:

- First of all, it presents the main elements of analysis to understand how the individualization is affecting



family relationships and how it is affecting the welfare. We will approach family diversity in Western society, especially the Spanish, with the emergence of new family forms.

- However, this goal can't be achieved if not analyzed other areas closely related to the family especially in welfare provision: the market and the state. The relationships between family, state and market constitute a central element of this course. Consequently establish the foundation necessary to analyze the relationship between welfare and family diversity with special reference to the consideration that the family receives public administration, both in the field of social protection and legally.

## EVALUATION

The attendance is a prerequisite for evaluation and must cover a minimum percentage of sessions (90%). Below this minimum, unless valid reasons, the student will not be evaluated. Percentage of the final score: 10% (SE1).

The assessment of learning of knowledge will be done through the following instruments:

- Observation and recording the participative attitudes of the students in the development of the tasks and activities related to the competences. Weight of the final score: 25% (SE2)
- Individual report. Weight of the final score: 65% (SE5)

The individual report will consist of a maximum of 25 pages (Times New Roman, 12 point, single spaced) in which will be assessed:

- Application of learning in the subject, which will be implemented in the use of the basic bibliography and recommended by teachers.
- Capacity critical argumentation.
- Search other sources of information and selection criteria.
- Correction in written expression.

Structure of individual report:

- 1 - Cover: title, name of the Master's degree, the name of subject, name of the student, academic course, delivery date.
  - 2 - State of the art.
  - 3 - Developing the theme.
  - 4 - Bibliography.
- Summary of the four selected references.
  - References: References used in the report, ordered alphabetically (only those cited in the state of art or the development of the topic).



- Other references. They include a list of references found on the chosen topic, which has not been used for report, ordered alphabetically.

The topic of the report will be communicated first to the subject coordinator, who may delegate the tutoring at the teacher most suitable. The report will be submitted in electronic format (pdf), with copy to the coordinator. The deadline for submission of the report will be the day fixed in the calendar of the Master's degree.
