## DESCRIPTION OF CONTENTS

The contents of the subject "External Practices" are those of the Master in Social and Educational Action. Its specificity lies in the teaching strategy used, which focuses on the professional experience carried out in one of the centers linked to the social and educational field, and on the analysis of the professional situations that occur there, from the conceptual and procedural tools addressed in the Master.



The External Practices will allow observing intervention situations in the minor and mediation fields, applying analysis strategies developed in the specialties and formulating specific intervention proposals.

The acquisition of the competencies formulated for the Master will be facilitated by the integrated development of the academic modules, the external practices and the final work of the Master, which, from complementary perspectives, address the critical analysis of socio-educational situations with special attention to the areas of minor and mediation, and its conceptualization as an object of research.

Each student will have a tutor in the practice center and another in the Faculty. The appointment of tutors will be based on the purpose of the work.
