SUMMARY

Module **44111 Research in Literatures: Diachronic Perspectives** is an elective module that forms part of the subject *Advanced Research in Languages and Literatures*, designed as a specialization to deepen the techniques and methodologies acquired in the compulsory modules. The module will introduce students to advanced aspects of literary research, focusing on the diachronic perspective.

It consists of two subjects: **Traditions in Western Literature and Their Reception**, and **The Rupture of Tradition**. Throughout the module, the main historical stages in the evolution of cultural expressions, especially literary ones, will be addressed, paying special attention to the phenomena that drive transformations and processes of renewal in the different periods studied.

The first subject, **Traditions in Western Literature and Their Reception**, offers a diachronic study of the evolution of Western culture, from the ancient Greco-Roman world to modernity. This approach is supported by the analysis of relevant or paradigmatic texts and authors that illustrate this process. The second subject, **The Rupture of Tradition**, focuses on the study of specific literary works with the aim of analyzing the extent to which they represent either a continuity or a rupture with respect to an established textual tradition.

To be capable of locating, managing and synthesising specialised bibliographic information, in both the target language used in the Masters Degree and other modern languages, either in libraries or in physical or online archives.

To develop an ethical commitment, focusing on aspects such as gender equality, equality of opportunities, values of culture of peace, democratic values and environmental and sustainability issues, as well as the knowledge and appreciation of diversity and multiculturalism.

DESCRIPTION OF CONTENTS

The module offers an introduction to Western literary tradition and the processes of transformation that



have shaped its evolution. Special attention will be given both to the classical origins and their reception across different historical periods, as well as to the moments of rupture and questioning of this tradition, with a particular focus on the 19th century and the impact of social crises on literature.

1. Traditions in Western Literature and Their Reception

- 1.1. The foundations of Western literary tradition: the Greco-Roman legacy.
- 1.2. The reception of classical culture in the Middle Ages.
- 1.3. The classical tradition in Humanism and the Baroque. Genres, forms, and themes.

2. The Rupture of Tradition

- 2.1. The 19th century: between modernity and contemporaneity.
- 2.2. Literature and health crises: cholera.

Through the development of these contents, students will achieve the following learning outcomes: they will be able to apply techniques and methods of literary text analysis and interpretation, both to study their transmission and to explore their intrinsic and extrinsic aspects. Furthermore, they will be able to apply appropriate methodologies to conduct research focused on literary works, either globally or on specific aspects. Finally, students will acquire the necessary knowledge to develop original and well-founded ideas, particularly within academic or research contexts.

TEACHING METHODOLOGY

The methodology will be structured on the explanation of the contents in class, along with practical examples that will be object of study, and on the materials and documents provided by the teachers. Sessions will consist of the systematic and theoretical presentation of the basic concepts in each unit and their application to specific cases through individual or group exercises.



The module integrates the Sustainable Development Goals (SDGs), promoting a critical and pluralistic perspective that encourages respect for cultural diversity (SDG 10: Reduced inequalities), equality (SDG 5: Gender equality), and social responsibility in the study of literatures (SDG 4: Quality education).

EVALUATION

The assessment will be distributed as follows: 50% will correspond to the completion of activities, assignments, and active participation in class, while the remaining 50% will correspond to the submission of an individual written paper of 6-7 pages in length (Times New Roman 12/ line spacing 1.5), focused on one of the two subjects included in the module.

The written paper may be resubmitted during the second assessment period.

With regard to class participation activities, 30% of this grade may be recovered in the second assessment period through an oral presentation before the teaching staff. This presentation will assess students' ability to analyse, argue and apply the course content.

In case the student passes only one of the two subjects during the first assessment period, the mark will be kept for the second assessment period.

The teaching staff reserves the right to request an interview with the student after submission of the written assignment.

In cases of plagiarism, the overall mark for the module will be recorded as FAIL.

Intellectual honesty is vital to an academic community, and for the fair evaluation of students' work. All work submitted for this course must be originally authored by every student. No student shall engage in unauthorized collaboration or make use of ChatGPT or other AI composition software, unless their use is part of the contents of the course and is authorised by the teaching staff.
